Brittany added that her name, e-mail address, her juvenile daughter's name, and Bradley's name have been used to create numerous social media accounts, primarily Facebook and dating profiles, some of which are sexual in nature. She stated that she is only aware of one person who would do this, which is her ex-boyfriend, and father of her daughter, Cody Mitchell.

Brittany advised that Cody had done this several times in the past after they ended their relationship, which prompted her to petition for an injunction for protection against domestic violence with minor children. The final injunction under Flagler County case # 2018-DR-0059 was signed by the Honorable Judge Smith on January 19, 2018. The injunction is non-expiring and one of the parameters includes "not having any communication with or about, including no social media accounts or communications".

I, Detective Ebrill, met with Brittany Cullison and Sheri Vitez (Brittany's mother) on November 25, 2019. Both advised that they have had ongoing issues with Brittany's ex-boyfriend, Cody Mitchell, creating fake accounts pretending to be them on Facebook and on several dating websites. They advised that Cody has been using these accounts to send several unknown subjects to Brittany's old residence, 7 Pier Lane, Palm Coast. Brittany and Sheri stated Cody is not aware that Brittany moved out of 7 Pier Lane, but Sheri has tenants at that location. They added that Cody gained access to one of Brittany's email account (brittnlove21@yahoo.com <<mailto:brittnlove21@yahoo.com>>), and has used it to activate the fake accounts. Cody has also allegedly made orders for pizza and Chinese food using her old e-mail address, and had the food delivered to 7 Pier Lane. She subsequently presented me with emails for three separate online orders made for Domino's Pizza, Pizza Hut, and Five Star Online Ordering. All three orders were made on Sunday, November 10, 2019.


Brittany and Sheri advised that Cody currently resides at 2192 York Road, Gettysburg, PA 17325. Sheri sent me several photographs of Facebook messages she received, primarily from fake Facebook accounts that she believed were created by Cody Mitchell. There were also messages from several unknown males claiming they had met Sheri or Brittany through dating sites such as Plenty of Fish.

Brittany subsequently presented me with several emails sent to her email account (brittnlove21@yahoo.com <<mailto:brittnlove21@yahoo.com>>) from Plenty of Fish. Each email indicated that someone was attempting to contact her through Plenty of Fish.

On December 6, 2019, I submitted a subpoena to legaldept@match.com <<mailto:legaldept@match.com>> in reference to obtaining subscriber information and IP Addresses for all "Plenty of Fish" accounts created utilizing the email address of brittnlove21@yahoo.com <<mailto:brittnlove21@yahoo.com>>.

I subsequently received the records for the "Plenty of Fish" accounts on January 7, 2020. The records indicated that there were eleven (11) "Plenty of Fish" accounts created utilizing the email address of brittnlove21@yahoo.com <<mailto:brittnlove21@yahoo.com>>. The accounts were created on the following dates, under the following usernames:

Ten of the eleven "Plenty of Fish" profiles contained a date of birth of May 1, 1986 (Brittany's date of birth). All accounts except for the two created on March 9, 2019 contained a common IP Address of 73.230.106.174.


On January 10, 2020, I submitted a subpoena to Comcast Cable Communications requesting subscriber information for the IP Address 73.230.106.174

On January 22, 2020, at approximately 12:03 PM, I received a response from Comcast reference the subpoena I submitted for information for IP Address 73.230.106.174. The response indicated that the IP Address was assigned to Kevin Ditzler, and the service address was listed as 2192 York Road, Gettysburg, PA 17325 (Cody's current address).

On January 22, 2020 at approximately 2:20 PM, I contacted Brittany and asked if anyone was possibly residing at 2192 York Road, Gettysburg, Pennsylvania with Cody. Brittany advised that Cody may be living with his brother, Kevin Ditzler.

On February 3, 2020, I submitted a subpoena for subscriber information to MeetMe.com for any accounts created under the email brittnlove21@yahoo.com <mailto:brittnlove21@yahoo.com>.

On February 4, 2020, I made contact with Sheri Vitez at the Flagler County Courthouse (1769 East Moody Boulevard, Bunnell, FL). Sheri reported that Cody was redirecting several males from the dating websites to

contact her directly via her Facebook Messenger on a near daily basis. Brittany does not have a Facebook account, and is therefore unable to receive Facebook Messenger messages. Based on this information, it was determined that Sheri was also a victim in this case. Sheri provided a sworn written statement in reference to the incident. The following is what was written in Sheri's statement:

- "Cody Mitchell has been harassing my family and myself for 3 years. He is making profiles on dating site and sending strange men to my daughters address in the middle of the night. He sends obscene pics and statements. Has been ordering Pizza + Chinese food and sending 5 of our old and new addresses (FL + PA) for months. Has mentioned using guns. He has gotten into my daughters bank and credit card account. Has had her electric turned off 4 times until we finally changed her bill into my name. Has called children services and claimed we were abusing my 1 + 3 year old granddaughters + had them come to our homes. Had to change phone numbers because of the harassment. Threatened to vandalize my property in Pa. Puts children pics on dating sites + said they made friends on site that want to have sex with them. Cody is a very unstable person. Trashed his daughter, my grand daughters, bedroom when she was 2 months old + took a saw to her crib and my face. I know that he resides in Pa. but he is OBSESSED with making us miserable. It is NON STOP for 3 years EVERY DAY. which is more concerning. He is a loner who doesn't have a life other than work and constantly harassing + threatening my family + many friends in Florida worried what it is going to escale to next!! Mostly concerned for my 1 + 3 yr. old grand dauthers if he sends the wrong person to their home!"

Sheri had previously sent me several screenshots via email, most of which were Facebook messages she received from males claiming they met her on dating sites. While speaking with Sheri on February 4, 2020, I photographed all screenshots that she had saved on her cell phone, as well as the timestamps for each screenshot. I observed screenshots of messages that Sheri's other daughter, Tiarra Cullison, received directly from Cody's Facebook account (Tiarra does not have an injunction against Cody). The messages were in reference to photos of one of Brittany's children being posted on "28 dating websites". The messages from Cody to Tiarra were sent throughout December of 2019, and read as follows:

- "If your pictures that you post on Facebook are on 28 dating websites. Who's fault was it to post something else's child on your Facebook?"
- "Did I post the pictures on Facebook or did you?"
- "So will you guys post another person child on Facebook so they go on dating sites? Lmfao"

- "You find that funny"
- "So why would Brittany post her first child all over the internet and then keep the other one in private. That's not fair for the first child right?"
- "Have both her children leaked all over the internet..."
- "I want brad beats to post his child of Facebook so his child is on 28 dating sites lmfao"
- "When I say I will never to somebody... I really mean it, I don't make up bullshit lies like sheri"
- "Never talk to somebody I really mean it"
- "Sherri was ignoring all the Facebook messages and now she wants to talk to random men again. So I guess she likes talking to men that have 20 pictures of your family with a child that isn't hers huh"
- "If you have a child on 20 dating sites with the pictures you posted on Facebook do you think the mother is a good parent"
- "If you spend time with the child that's on 20 dating websites how does that make you and your family look"
- "Your mother is on meet me messaging Random man on that website and she said she's gonna call the cops about it"
- "But the cops don't care so what's the point of calling the cops"

Sheri also took screenshots of several messages she received from a fake Facebook account under the name "Brittany Cullison". The timestamp indicated that the messages were received on February 3, 2020, and read as follows:

- "Sheri Vitez when are you going to post Brittany cullisom ugly second child she had with brad Beats so that fucked up child will be on 28 dating sites?"
- "So Sheri Vitez when is you and brad beats going to post more peoples children on line so people on OkCupid can get there updates of your guys kids photos?"

Sheri advised that Cody created several fake accounts under Brittany's name as well as under the names "Tiarra Cullison", "Barry Vitez", "Brad Beats", and "Sheri Stonesifer Vitez".

On February 5, 2020, Brittany sent me an email stating that Cody was attempting to access her TurboTax account.


On February 7, 2020, I received an email from Sheri stating that Cody was on Zillow trying to sell Brittany's old residence.

On February 10, 2020, I received an email from Sheri with screenshots of Brittany's "Pinterest" page. Sheri advised that Cody had logged into Brittany's Pinterest page and began posting inappropriate "pins" to her account, one of which read "I fucked two brothers and got Chlamydia from them".

I also received an email from Brittany on February 10, 2020 stating that Cody was "posting sexual stuff" on her old Pinterest account under her name. The email contained a photograph of an email she received from Pinterest, stating that one of her "Pins" was removed "because it was against" Pinterest's "policies on sexually explicit or pornographic content."

On February 14, 2020, Brittany sent me two photographs of her old Pinterest account with several Pinterest "boards" titled as follows:

- "I fucked two brothers and got Chl..."

On February 19, 2020, Sheri forwarded an email to me from the dating site "MeetMe". The email was an activation email, stating "Hey Brittany Cullison, welcome to MeetMe, the best place to meet new people." It provided a link to activate the MeetMe account.

On February 20, 2020, Brittany sent me an email stating that Cody was writing reviews under Sheri's old daycare. She sent me a photo of the review which read as follows: "Sheri stoniesifer vitez would feed the kids McDonald's food to the Spanish children so when they went home from there mother they would have the shit's from it Sheri vitez has herpes and doesn't know how she got it and finally has fake tits"

I received a voice message from Sheri on February 20, 2020 stating that Cody was now affecting her livelihood by posting the review mentioned above.

On March 9, 2020, I spoke with Sheri who advised that several unknown males recently traveled to 7 Pier Lane, Palm Coast, usually asking for Tiara or Arabella (Brittany's three-year-old daughter). She stated that one male in a vehicle arrived at 7 Pier Lane at 4:30 AM on March 9, 2020. Sheri stated the residents told her that the male pulled into the driveway and "laid on the horn" until someone came out. She added that two males were also observed waiting in a vehicle the night before, asking for Tiara. This incident was reported to deputies on March 9, 2020 at 4:31 AM.

On March 10, 2020, at 3:27 PM, I received a response from MeetMe in reference to the MeetMe dating profile created utilizing Brittany's email address, brittnlove21@yahoo.com <mailto:brittnlove21@yahoo.com>. The login history provided a total of twelve (12) IP Addresses used between December 4, 2019 at 4:35 AM and January 31, 2020 at 4:41 PM. Out of the twelve IP logs, the IP Address 73.230.106.174 appeared six times. As noted above, for IP Address 73.230.106.174 was assigned to 2192 York Road, Gettysburg, PA 17325 (Cody's

current address). The other six IP addresses appeared to fluctuate between Los Angeles, California, Dallas, Texas, and Miami, Florida. Upon running these IP Addresses through DNSChecker.com, it was discovered that all six were assigned to "QuadraNet", an internet hosting company with servers in Los Angeles, Dallas, Miami, Atlanta, Chicago, New Jersey, Seattle, and Amsterdam.

On March 17, 2020, Sheri called law enforcement to report that more subjects were knocking on the door of Brittany's old residence (7 Pier Lane, Palm Coast). She advised that the subjects were sent there by Cody via a dating website.


On the night of March 25 through March 26, 2020, Sheri reported that Cody began sending several unknown subjects to her own residence at 134 Breeze Hill Lane, Palm Coast. I located three calls for service on the following dates and times:

- March 25, 2020 at 8:47 PM: Sheri reported that Cody was having Pizzas delivered to her own residence.
- March 25, 2020 at 11:30 PM: Sheri reported that people from a dating site honked their horn, and then knocked on the door to her residence. At 11:50 PM, she advised another vehicle arrived and was in her driveway.
- On March 26, 2020 at 12:22 AM, Deputy Beane made contact with the driver of another vehicle that arrived at the residence. The driver was advised to post on the dating site to not go to this location.

It should be noted that on March 25, 2020 at 8:18 PM and again at 10:15 PM, Sheri reported that there were also subjects honking their horn and knocking on the door of 7 Pier Lane, Palm Coast.

Based on these reported incidents and the information obtained from the IP Addresses, Cody is being charged with two counts of aggravated stalking against Brittany and Sheri. Sheri and Brittany advised that these incidents have been ongoing for three to four years, and the cyberstalking has not ceased despite the fact that Brittany obtained a non-expiring injunction for protection against Cody. Both also advised that they are in fear for their safety, as well as the safety of Brittany's juvenile daughter, due to the fact that numerous unknown males from dating sites have been sent to Brittany's old address as well as Sheri's address, looking for Brittany, Sheri, and Brittany's daughter.

Cody's information was run through NCIC/FCIC and CLEAR, and his most recent address as of January 21, 2020, per his Pennsylvania Driver's License, is still 2192 York Road, Gettysburg, Pennsylvania.
