My ATTORNEY wrote IN HIS motion FOR DISQUALIFICATION (THAT I DID NOT READ, OR APPROVE) THAT THE GROUNDS FOR MY RECUSE & "ARGUMENT" 16-18 WERE MY LAWYERS PROBLEM WITH HOW HE WAS TREATED IN COURT, where he's "Bechooing & whining" like a kid that got his feelings BECAUSE OBVIOUSLY HE DIDNT LIKE HOW HE WAS TREATED. NOW, I COULD CARE LESS ABOUT MY LAWYERS FEELINGS, OR THAT HE'S TRY'N TO SQUEEL ON YOU LIKE A YELLOW LITTLE SISSY. I DID NOT BASE MY RECUSE, OR MY ARGUMENT WITH THE COURT ON THE FACT MY LAWYERS A PATHETIC CRYBABY. I BASED MY RECUSE, & MY ARGUMENTS ON WHATS IN THE SWORN AFFIDAVID I FILED!! OF COURSE YOU DENIED IT ON LACK OF EVIDENCE, THAT PATHETIC EXCUSE FOR AN ATTORNEY WENT AGAINST EVERYTHING I WROTE & THE FACTS & TRUTH TO MY REASONS, MY RECUSE, MY ARGUMENT. I HAVE BRAIN DAMAGE, I'M SLOW, I HAVE TO TAKE A LONG TIME TO FIGURE THINGS OUT. NOW IF YOU READ MY AFFIDAVID & ARGUMENTS, SIR THERE IS NO DENYING MY ARGUMENTS, OR EVIDENCE OF MISTAKES MADE THAT HAVE TO HAVE MY CASE DISMISSED. I'M PERMANENTLY DISABLED, NOT ON MY PROPER MEDICATION DENIED THE PROPER MEDICAL CARE I HAVE TO RECEIVE, I'VE BEEN FORCED TO SIT IN ISOLATED SOLITARY CONFINEMENT FOR A YEAR AND A HALF!! SIR, WITH ALL DO RESPECT, I'VE GOT MORE EVIDENCE THAN LAW ALLOWS THAT PROVES MY INNOCENCE, THERE'S BEEN EVIDENCE WITH HELD (VIDEO & AUDIO) BY A MAN NAMED "YEV" WHO OWNS THE CLUB I WAS ARRESTED AT, THAT PROVES MY INNOCENCE. AN INMATE IN THERE NAMED CHARLES SWINNEU, HIS EX-WIFE, GIRLFRIEND, & THE SOURCE TRIED TO ELICIT \$5000.00 DOLLARS FROM MY FATHER & I FOR IT & I'VE GOT WITNESSES, PHONE RECORDS, & MY FATHER EVEN SPOKE WITH THE MAN. THE MAN EVEN TOLD ME HE MURDERED A BOY THAT RAPED "YEV'S" DAUGHTER & THAT "YEV" PULLED THE VIDEO BEFORE INVESTIGATORS COULD GET ALL OF IT BECAUSE OF OTHER THINGS UNRELATED TO ME HE DID NOT WANT SEEN. I DONT CARE ABOUT WHAT THOSE TWO HAVE DONE, I JUST CARE ABOUT MY FREEDOM, THE FACT IM INNOCENT AS THE ONLY IS LONG, THAT 2 OR 3 NEW WITNESSES STEPPED UP ON MY BEHALF, GAVE TESTIMONY (SWORN TESTIMONY) OF WHICH I HAVE, & WOULD TESTIFY ON MY BEHALF, THAT MY LAWYER HAS STILL YET TO TAKE DEPOSITIONS ON. YOU FOUND ME ITP ON AUGUST 26TH 2014 BASED ON DOCTOR CATHY'S REPORT, DR. CATHY'S EVAL COURT CIDER'S FOCUS WAS ON BRAIN DAMAGE STATUTES 916.302 & 916.3012. THAT'S A STATUTE ON "INTELLECTUAL DISABILITY" NOT MENTAL ILLNESS. "INTELLECTUAL DISABILITY" WAS FOUND IN CATHY'S REPORT, IN FACT A "DUAL DIAGNOSIS" WAS, OF WHICH FALLS UNDER STATUTES UNDER "INTELLECTUAL DISABILITIES" NOT MENTAL ILLNESS. THE COURT MADE THE MISTAKE OF GIV'N UNDER STATUTE 1916.12(3). THAT'S THE STATUTE FOR MENTAL ILLNESS NOT INTELLECTUAL DISABILITIES. BRAIN DAMAGE IS PERMANENT AND UNDER FLORIDA STATE LAW IS MENTAL RETARDATION, OF WHICH IS AN INTELLECTUAL DISABILITY. I DISAGREE WITH ALL 3 CHARGES FOR THE FACT I HAD AN ADVERSE REACTION TO NEW STEROIDS FOR LOW D mixed with like 16 PSYCHOTROPIC PILLS A DAY & WAS BEATEN OUT FOR WEEKS & THE WHOLE DAY I WAS ARRESTED. I DIDNT KNOWINGLY DO ANYTHING & WHEN I DID COME OUT OF BEIN BEATEN OUT FROM BEIN ALMOST BEAT TO DEATH THAT BOY FELL FACE 1ST ON THE KNIFE I STUCK OUT TO TRY TO SAVE MYSELF 18 ON IT IS NOT A FAIR FIGHT & AS I TOLD YOU BEFORE I DIDNT STAB ANYONE, THE REST I DONT EVEN REMEMBER. MY LAWYER DIDNT EVEN FOLLOW MY AFFIDAVID FOR MY RECUSE - I WANT TO FIRE HIM, HE'S CORRUPT & WORTHLESS, I'VE GOT TEXTS FROM HIM BREAK'N LAWYER CLIENT CONFIDENTIALITY, THEM ADMIT'N HE'S PUT MY CASE OFF FOR MONTHS BECAUSE OF HIS DILIGENCE. BUT I WANT THE MONEY BACK HE WAS PAID. & I NEED HELP WITH THINGS. IT'S OBVIOUS THE WOMAN HAS SOME KIND OF HATREDE FOR ME WHEN I DONT KNOW HER, NEVER DID ANYTHING TO HER, NEVER DID ANYTHING WRONG.. YES I'LL SAY IT AGAIN, I DID NOTHING WRONG!! I TOOK MY MEDICINE AS PRESCRIBED, IT MESSED ME UP, I HAD BLACKOUTS FROM IT & AM NOT, NOR WILL EVER BE RESPONSIBLE FOR WHAT HAPPENED. THE REST, WELL.. YOUR HONOR, IM RIGHT ABOUT MY ARGUMENT.. I'VE GOT MORE THAN ENOUGH PROOF, I'VE GOT PEOPLE COMING OUTTA THE WOODWORK GIVEN SWORN STATEMENTS & WILL TESTIFY ON MY BEHALF. TRUTH IS, I DONT NEED THEM TO. YOUR HONOR, YOU AND THE STATE KNOW IM GUILTY OF NOTHING!! THE STATE KNOWS THEY HAVE NO CASE, & YOU KNOW IM RIGHT IN MY ARGUMENTS.. BUT, I'VE BEEN NETHIN BUT TORTURED. YES, TORTURED FOR THE PAST 1/2 YEARS SINCE IN SAIT.
