NARRATIVE The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the 19th day of February, 2014, at approximately 10:43 a.m. p.m. at FLAGLER BEACH within FLAGLER County, violated the law and did then and there:

On February 19, 2014 at 6:05 PM I was dispatched to [redacted] in reference to a civil call. Upon arriving on scene I made contact with the victim, Theresa Ann Canfield. Ms. Canfield works in the [redacted] as a cashier. Ms. Canfield told me that at approximately 5:45 PM she saw the above named defendant drive by the front of the liquor store in a white van. Ms. Canfield said that the defendant was looking inside the store and that she made eye contact with him. Ms. Canfield said that the defendant then immediately looked away and continued to drive eastbound in the white van. Ms. Canfield told me that this made her very nervous because she just had an injunction put in place against the defendant on February 13, 2014. Ms. Canfield said that she has the same work schedule now as she did when she was dating the defendant and that he knows what days that she is at work. Ms. Canfield also said that she feels harassed and threatened by the defendant and is afraid of what he might do next.

Ms. Canfield told me that she and the defendant were in an intimate relationship for 10 months which she ended in January of 2014. Ms. Canfield said that she and the defendant started dating in March of 2013. Ms. Canfield also told me that on the evening of January 31, 2014, the defendant sat outside of her residence until the next morning at 6:15 AM when he rang her doorbell. Ms. Canfield said that she was on a date on the evening of January 31, 2014 and the defendant was sending her text messages in regards to what she was doing inside her house. Ms. Canfield said that the defendant was describing in detail what she was doing inside her residence on the evening of the 31st. Ms. Canfield also said that she doesn't have any window treatments on her sliding glass door, which would have allowed the defendant to look inside her residence.

At 8:34 PM this evening I went to the defendant's residence at 139 Avalon Ave to further investigate what happened. I made contact with the defendant at his front door and read him his Miranda Rights at 8:38 PM. At this time the defendant advised that he would speak with me in regards to what happened. When I first asked the defendant if he had driven by Ms. Canfield's place of employment, he replied "no." The defendant said that he had only been at his house all day and that he had went to Palm Coast earlier in the day. After the defendant was taken into custody without incident he changed his story and told me that he had been by Ms. Canfield's place of employment twice today. The defendant said that he rode by the Publix liquor store earlier in the day to see if Ms. Canfield was there and then he went back by the store at approximately 5:45 PM.

The injunction was put in place against the defendant on February 13, 2014 and is effective until June 1, 2014. The injunction states that the defendant is not supposed to come within 500 feet of Ms. Canfield's employment or within 100 feet of her vehicle. The injunction was verified through Flagler County Sheriff's Office dispatch.

The defendant was taken into custody without incident and transported to the Flagler County Inmate Facility. Ms. Canfield provided a written statement in regards to what happened. Ms. Canfield was also provided with a Domestic Violence Notice of Rights and Remedies packet and advised of who our victim advocate is.

No further information or action by this officer.
