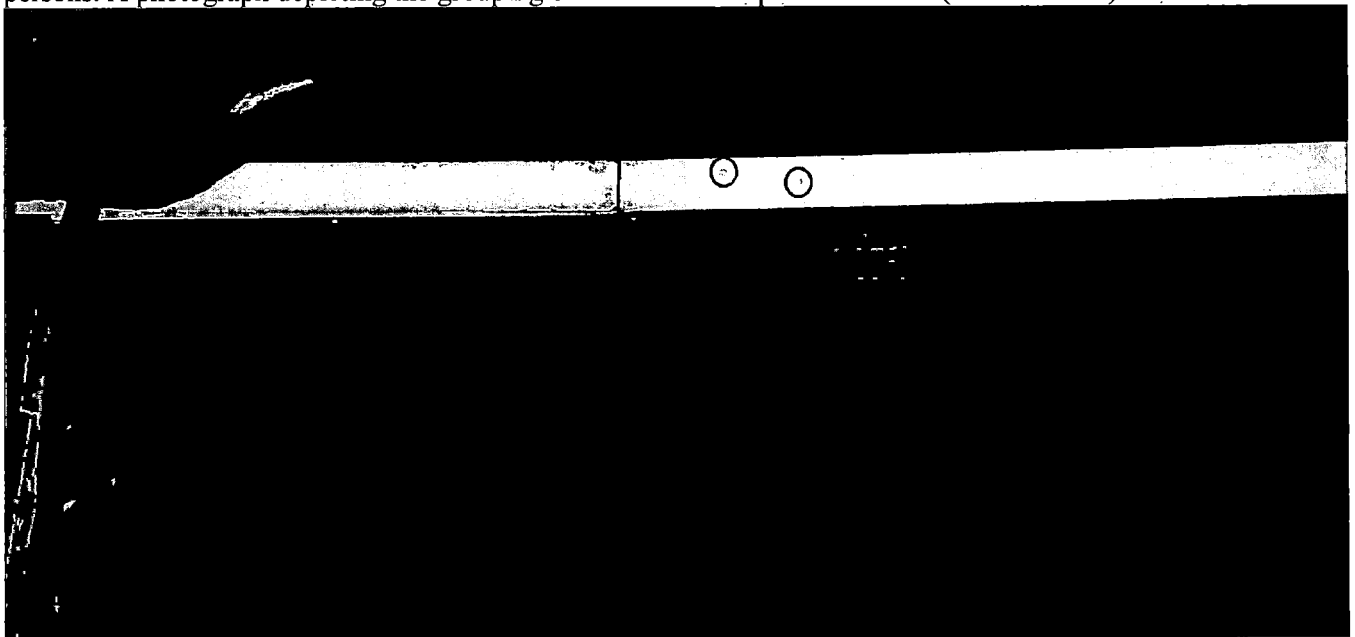

the residence when the light from the ceiling fan above them shattered. It should be noted that multiple loud noises, consistent with gunshots and/or fireworks, were heard by individuals on scene. The glass from the ceiling fan light globe struck at least one person on the patio. The victims noticed the shattered window, as well as holes in the porch screen, the lanai framing and in a wall inside of the residence. Upon discovering this, they were able to determine that the damage resulted from projectiles. Crime Scene Investigator Woody determined that there were a total of four (4) rounds that struck the residence of [REDACTED] just above the heads of several persons. A photograph depicting the grouping of the rounds are pictured below (circled in red):



It should be noted that the homeowner of [REDACTED] stated the only person in the area that was of note was "Jay" who lives at 97 Bressler Lane. Ultimately, "Jay" was positively identified to be Jamal Kariem Ne Jame (suspect). [REDACTED] explained that "Jay" moved in a few months prior and they have only spoken once, briefly, while introducing themselves. The victims explained that they are friendly with all of the other neighbors in the area.

During the initial neighborhood canvass, Deputy Beausoleil made contact with Jamal at approximately 2200 hours. Jamal allowed Deputy Beausoleil to look at his fence for bullet holes. While doing so, Jamal advised the

individuals at 100 Bridgehaven Drive were shooting off loud fireworks. No bullet holes were located by Deputy Beausoleil.

CSI Woody was able to determine the trajectory of the bullet holes found in the victim's residence and traced them to 97 Bressler Lane; Palm Coast, Florida 32137. The bullet that broke the window and lodged into the wall of 100 Bridgehaven Drive was recovered and appeared to be of good quality for comparison.

Detective Costello conducted surveillance on the residence of 97 Bressler Lane beginning at approximately 2306 hours. No persons were observed leaving or entering the residence.

On July 5, 2021 at approximately 0340 hours, the search warrant for the residence of 97 Bressler Lane was executed. There were two (2) occupants of the residence: Jamal Kariem Ne Jame (suspect) and Barbara Russell Johns (witness). Both individuals were secured and separated.


Barbara was read the search warrant for the residence and her Miranda Rights off of an agency issued Miranda Form. Barbara agreed to speak with law enforcement. Barbara was explained that law enforcement was on scene in reference to a shooting that occurred in the area. When asked, Barbara explained that she met "Jay", also known as Jamal, a few months ago and they have been seeing one another off and on. Barbara stated that she arrived at his residence in the late afternoon hours and was watching television with Jamal. During this time, Barbara disliked the movie they were watching and she went into the bedroom and laid down at which time Jamal stayed in the living area. Barbara explained that she has an eye issue and she put medicine in it when she laid down. Barbara stated she heard a lot of loud noises that she believed were fireworks. Barbara provided a sworn written statement and consented to providing a sample of her DNA. Barbara was allowed to grab the little personal belongings that she had at Jamal's residence (97 Bressler Lane). It should be noted that Barbara had one (1) dresser drawer in the master bedroom and some belongings on the night stand.

Jamal was read the search warrant for the residence and his Miranda Rights off of an agency issued Miranda Form. Jamal stated that he wished to speak to his attorney.

The execution of the search warrant at 97 Bressler Lane resulted in the recovery of various items of evidentiary value, some of which are listed below:

- Five (5) 9mm cartridge casings located in the backyard of the residence
- Seven (7) 9mm handguns were located in various locations throughout the property

The projectile recovered from 100 Bridgehaven Drive, the five (5) cartridge casings and a Glock 9mm bearing Serial Number BNFP422 were sent to the Florida Department of Law Enforcement (FDLE) in attempts to

identifying the firearm used in the crime. FDLE was able to positively identify the Glock 9mm bearing Serial Number BNFP422 as the firearm utilized in the shooting. It should be noted that during the execution of the search warrant at 97 Bressler Lane, this firearm was located in the closet of the master bedroom in a dresser drawer.

I, Detective Gordon, made contact with Barbara (witness) by phone who agreed to meet with me to discuss the case further. Barbara explained that she only recently began to stay over at Jamal's residence on occasion. Barbara had very few personal belongings at Jamal's residence (97 Bressler Lane). Barbara stated that she had an item of clothing hanging in the master bedroom closet, but it was put there by Jamal. Barbara explained that she only been in the master bedroom closet to grab clothing from the laundry bin. Barbara stated that she had a single dresser drawer in the master bedroom for various personal items. When asked if she has ever touched any firearm in the residence of 97 Bressler Lane, she stated she has. Barbara stated that one time, a "black" handgun was on the edge of the kitchen counter and she moved it away from the edge. Barbara was unable to recall how she moved it but stated that she did not go near the trigger area. Barbara does not know what type of firearm it was but explained it could have been his work service weapon as Jamal is an armed security guard. In regards to the night of July 4, 2021, Barbara stated that she arrived at 18:42 hours and was in bed prior to speaking with her mother at 2326 hours. Barbara stated that she was in bed for approximately 2-3 hours before speaking to her mother due to not liking the movie Jamal was watching and to rest her eye as it was hurting due to her eye issue. It should be noted, Barbara stated that Jamal was in and out of the bedroom and bathroom throughout the night. Barbara stated she thought the noises she heard throughout the night were fireworks. Barbara stated she was not the one that committed this crime.

The facts and circumstances of this case were discussed with Commander Emery whom is the FCSO SWAT Team Commander, an FDLE certified firearms instructor, and an Advanced Glock Pistol Armorer, among numerous other things. Commander Emery stated that shooting in a grouping, as depicted above, from that distance is difficult for an avid and experienced shooter even if they are intentionally attempting to hit their intended target while standing in the proper stance.

Due to the facts and evidence above, there is sufficient probable cause to believe that Jamal Kariem Ne Jame did wantonly or maliciously shoot at a private residence, in violation of Florida State Statute 790.19.
