YOUR HONOR, YOU COURT ORDERED ME TO LET YOU KNOW AT MY LAST APPEARANCE IF MY COURT ORDERED MEDICATION WAS DENIED TO ME. THE SAME NIGHT YOU ISSUED A NEW COURT ORDER FOR MAKING THE MEDICAL STAFF GIVE ME MY MEDS, I WAS DENIED. I PUT THE FAULT ON THE JAILS "DOCTOR CARTER" & THE "HEAD OF MEDICAL STAFF, AN RN NAMED CHRIS" AFTER MY GRIEVANCE WAS FILED & I THREATENED TO SUE, DR. CARTER SAID HE WOULD TELL CHRIS TO TELL STAFF TO MAKE SURE I TOOK MY MEDS. THIS WAS 4-5 DAYS PRIOR TO MY LAST HEARING & YOUR COURT ORDER. ALSO, I TOLD DAUG WILLIAMS & I HAVE HEARD NOTHING IN RETURN, YOU ALSO SPECIFICALLY SAID YOU ORDER ME TO STAY IN CONSTANT CONTACT WITH MY ATTORNEYS, BUT NOBODY AT THE JAIL, BUT OFFICER WILL LET ME USE THE PHONE, OF WHICH I'M ENTITLED TO JUST LIKE EVERYONE ELSE. IN 2 YEARS I'VE NEVER BEEN IN ANY TROUBLE, NOT EVEN A C.C. LASTLY, I CAN'T KEEP UP WITH WHAT GOES ON IN COURT, IT'S TOO FAST FOR MY BRAIN DAMAGE & MESSES WITH MY ANXIETY, & I ONLY REMEMBER WHAT I WRITE DOWN (WHICH IS USUALLY ABOUT 25% OF WHAT TAKES PLACE). BUT, THE STATE HAS & HAS HAD MY MEDICAL RECORDS!! SHE'S HAD THEM SINCE DAY ONE, & THE OLD JUDGE HAD THEM & SEALED THEM ON HIS OWN AS DEFENCE EVIDENCE EXHIBIT A. THEY STATE IM A 100% PERMANENTLY & TOTALLY DISABLED VETERAN. EVERYONE KNOWS A VA-100% LETTER IS YOUR COMPILED MEDICAL RECORDS, THE STACKS OF 15 YRS OF VA MEDICAL RECORDS SHE WANTS, SHE HAS, COMPILED IN A NICE 9 PAGE LETTER THAT EXPLAINS EVERY ONE OF MY DISABILITIES IN GREAT DETAIL. SHE NEEDS NOTHING ELSE, I HAVE NOTHING TO HIDE, SHE'S WASTING EVERYONES TIME!! SHE ALSO KNOWS THAT I WAS FOUND D.F.P. ON A 916-302 & 916-302 STATUTE, I HAD THE JUDGE CHARGE IT AFTER THE FOUND & CHARGE IT ON PAGE 24, 4-24 OF THE AUG 26 2014 HEARING TRANSCRIPT.
