R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: FREDIE JILES LEON on or between April 1, 2017 and May 6, 2017, in the County of FLAGLER and State of Florida, did commit sexual battery, as defined in 794.011(1)(h), upon E.M.R., a person 12 years of age or older but younger than 18 years of age, without E.M.R.'s consent, by penetrating E.M.R.'s vagina with his penis, and in the process thereof did not use physical force and violence likely to cause serious personal injury, and FREDIE JILES LEON was 18 years of age or older at the time of the offense, contrary to Florida Statute 794.011(5)(a). (1 DEG FEL)

COUNT II: IN THAT FREDIE JILES LEON on or between April 1, 2017 and May 6, 2017, in the County of FLAGLER and State of Florida, did commit sexual battery, as defined in 794.011(1)(h), upon E.M.R., a person 12 years of age or older but younger than 18 years of age, without E.M.R.'s consent, by penetrating E.M.R.'s vagina with his penis, and in the process thereof did not use physical force and violence likely to cause serious personal injury, and FREDIE JILES LEON was 18 years of age or older at the time of the offense, contrary to Florida Statute 794.011(5)(a). (1 DEG FEL)

COUNT III: IN THAT FREDIE JILES LEON, on or between April 1, 2017 and May 6, 2017, in the County of FLAGLER and State of Florida, unlawfully did offer E.M.R. marijuana in exchange for sexual acts, which did cause, tend to cause, encourage or contribute to E.M.R., a child, to become a delinquent or dependent child, or a child in need of services, contrary to Florida Statute 827.04(1)(a). (1 DEG MISD)
