Upon arrival, deputies found the victim, [REDACTED] sitting at the dining room table with a laceration of his forehead, along with an apparent broken nose. While deputies entered the residence, deputies observe blood on the floors and along the walls.

[REDACTED] stated his stepson, Adrien Otero, and he got into a verbal argument. During the argument, [REDACTED] stated Adrien threw a water bottle at the wall in the living room, then proceeded to start punching [REDACTED] in the face. I inquired what caused the argument, to which [REDACTED] stated they have been arguing for the past months, and it finally escalated.

Upon medical units providing aid to [REDACTED] medics stated they believed [REDACTED] nose was broken, and the laceration on his head needed stitches. [REDACTED] refused to be transported by ambulance to Advent Health.

While medics attended to [REDACTED] I spoke with the reporting party, Katherine Jankowski. Katherine stated she was upstairs when she heard "loud sounds" coming from downstairs. Upon Katherine investigating the noise, she observed her son Adrien fighting with her husband [REDACTED]. After this, Katherine stated Adrien left the residence in her grey Chevrolet Equinox, bearing Florida Tag GMEL89.

I inquired with both [REDACTED] and Katherine would have gone. Both stated they do not know where Adrien lives, nor where he would be. [REDACTED] stated he may be with his girlfriend in the Mondex, but does not know her name or address.

While on scene, medics on scene stated they observed a handgun with blood on it in a drawer in the kitchen. I asked both [REDACTED] and Katherine why a handgun with blood was observed on it. Katherine stated both [REDACTED] and her have CCW's licenses and carry on their person. After the altercation, Katherine removed the handgun from [REDACTED] person and secured the handgun in a drawer. Both Katherine and [REDACTED] stated the handgun was never used or involved in the altercation.

Due to the physical evidence on scene, along with the written sworn statements provided, a charging affidavit was completed referencing Felony Domestic Battery, due to the disfigurement and damage [REDACTED] sustained from Adrien.


The vehicle's tag was "hotlisted" into the LPR system.

Both [REDACTED] and Kathrine provided written sworn statements, which were submitted into records.

[REDACTED] invoked Marcy's Law, with the form being submitted into records.

Deputy Stanford took several photographs of [REDACTED] injuries and photographs of the found handgun, uploading them into Ageis.


