NARRATIVE		<p>The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the <u>22nd</u> day of <u>August</u>, <u>2012</u>, at approximately <u>2225</u> <input type="checkbox"/> a.m. <input checked="" type="checkbox"/> p.m. at <u>FLAGLER BEACH</u> within <u>FLAGLER</u> County, violated the law and did then and there:</p> <p>On August 22nd, 2012 at 2225 hours I was dispatched to the 800 Blk. of Moody Ln. reference subjects fighting in the middle of the road. Upon coming on scene in the area dispatched advised that two subjects got into a red four door car and was leaving the area. A red Dodge Charger passed by my patrol car in the 400 Blk. of Moody Ln. and I turned around and was able to stop the car at the base of the bridge on Moody Blvd. I made contact with the driver, Jamie Paffumi and her husband (passenger), Jeffrey Paffumi. I noticed Jeffrey was shirtless, sweaty, breathing heavily, and smelled of an alcoholic beverage. Jeffrey was very angry and aggressive towards law enforcement on scene. I also observed Jeffrey punch the dash in the car twice and noticed the LCD screen in the car cracked. Sgt. Shamp came to my location and advised there were two mailboxes that had been knocked off of their posts. Also on the ground next to the mailboxes was a ripped black shirt.</p> <p>I had Jamie step out of the car so I could speak with her. I asked Jamie how many mailboxes Jeffrey had knocked down and she stated she knew he knocked one off but was unsure if there was any more. Jamie said that Jeffrey was wearing a black tank top which he ripped off during their argument. I asked Jamie if her husband had hit her and she said no, but that he gets angry when he consumes alcohol. This is the second time I personally have had to deal with Jeffrey when he is intoxicated, screaming and yelling at Jamie. Jamie refuses to confide in law enforcement if Jeffrey is abusing her or not. Jamie was issued a Domestic Violence Notice of Legal Rights and Remedies Packet and signed "do not" wish to pursue charges.</p>



Jeffrey came out of the car before being asked to exit and was still aggressive towards law enforcement on scene. Jeffrey continued to "bow up" and telling us that "we could zap him" but to let Jamie leave. I advised that Jamie was not free to leave until my investigation was over. At this point Jeffrey started to walking towards me asking "who are you". I told Jeffrey to back off at which point he turned around and squatted on the ground and put his hands on his head. I restrained Jeffrey for officer safety reasons. Jeffrey was place under arrest for criminal mischief.

Jeffrey was transported to the Flagler County Inmate Facility without incident.

Ofc. Pineda went to the location and took pictures of the damaged mailboxes. Ofc. Pineda submitted a CD containing pictures of the damaged mailboxes into evidence.
