Actually and intentionally encouraged his legally adopted daughter who was between the ages of 8 and 9 years old to masturbate her self while lying on a bed after he had her skinny dip (swim naked) in their pool to wit:								
On 1/3/07 during a taped interview, the 16 year old victim stated when she was between the ages of 8 and 9 years old when she and her family first moved to 84 Pin Oak Ln., the defendant made her on several occasions skinny dip in their pool then sent her to a bedroom telling her to masturbate herself. The victim said the defendant once had her masturbate herself while lying on the bed while he watched. The victim said the defendant would give her back rubs which later led to him rubbing her inner thighs. The victim said the defendant during the same time frame had made her watch the "Girls Gone Wild" videos and made her view pornography on their home computer. The victim described the pornography to be that of underage girls that were posing naked. She said the girl's breasts and facial features looked young and underdeveloped.								
On 1/3/07 a taped interview was also conducted with the defendant's 24 year old adopted daughter. The victim said between the ages of 12 and 13 years old while she was in 6th or 7th grade while attending middle school, the defendant began touching her inappropriately. The victim said the defendant began rubbing her back then eventually asked her to remove her shirt. She said this occurred on numerous occasions which led to him rubbing the inside

of her legs, vagina and then digitally penetrating her. She said most of the incidents occurred while their family lived on Willowgrove Pl. in Flagler County. She said the incidents would occur mainly on the weekends when the defendant would come into her bedroom in the middle of the night. She said she was asleep in the top bunk bed while her younger sister was asleep on the bottom bunk. She said the defendant would wake her up in the morning by rubbing her vagina inside her underwear. The victim said once while she was sleeping in the living room on a pull out couch, the defendant layed down behind her, took her hand placing it on his penis, and with his hand on top of hers began to masterbate him. The victim said when the defendant would travel for work, she and her siblings would often take turns going with him. She said once when she went with him out of town, the two who shared a bed, played the card game UNO. She said if she one, he would give her \$5, and if he won, she would have to show him her breasts for 5 seconds. She also said while they were away, the defendant made her "flash" (expose her breasts) while semi trucks past by. She said he touched her breasts while she exposed herself to the vehicles.

The victim said the innappropriate touching stopped around the age of 16 when she confronted him telling him it was wrong.

The victim said when she was 19 years old, she believed she was having a online affair with a young male. She said she confided in the defendant who inturn took her to a porn shop/adult super center in Cocoa Beach FL. where he assisted her in buying a vibrator and pornography magazines. The victim stated she later found out from her mother that the male she was having the online relationship with was her defendant/father. This information reference the computer was later confirmed by the defendants wife/victim's mother during a taped interview.

When the defendant found out that his daughters had disclosed the above statements, he fled the residence and left both daughters and wife hand written letters apologizing for what he had done in the past. The defendant made several phone calls to friends and family admitting what he had done was wrong and that he had "fucked up" and apologized for not telling his wife what had occured in the past when the computer incident was revealed. The defendant asked a friend if his wife and daughter had given a statement to law enforcement and indicated if they had, he knew a warrant would be issued for his arrest.

The defendant voluntarily turned himself in with the presence of legal counsel and declined to give a statement.
