Drive, and drove back in front of the house towards Louisville Dr. After the vehicle turned around Phillip (Sr) started shooting back at the Phillip Jr in the white vehicle.

Jeneen Haire stated she was outside with Phillip (Sr) and Sergeant Reynolds. Jeneen saw her son, Phillip Haire Jr in the driver's seat of a white vehicle as it drove down London Drive. Jeneen locked eyes with Phillip Jr; Phillip Jr pointed a gun out the driver's window and began firing the weapon toward them.

Phillip (Sr) advised he was standing outside with Sergeant Reynolds and Jeneen when he saw Phillip (Jr) sitting in the driver's seat of the white vehicle as it drove down London Dr. Phillip (Sr) heard gun shots coming from the vehicle. The white vehicle turned around and drove back in front of the house, Phillip (Sr) shot back at the white vehicle. Phillip (Sr) advised the vehicle was a white Pontiac Grand Am and it belonged to Phillip's friend Daniel Hull. The Pontiac then made a right turn onto Louisville Dr.

At approximately 1710 hours, Samuel Nutter, called and reported he was car jacked on US 1. Samuel stated he was driving northbound on US-1 in his Gray 2013 Ford Fiesta (VIN: 3FADP4BJ3DM199306) Florida tag EEYR82. Nutter saw a white Pontiac cross over the median and into north bound lanes of US-1. Nutter stopped to make sure the occupant(s) were okay. A black male exited the white Pontiac with a chrome pistol in his hand. The black male told Nutter that he did not want to shoot him but he needed his vehicle. Nutter provided the black male with the keys to the Fiesta. The black male again advised Nutter he did not want to shoot him. The black male then left in Fiesta last seen going northbound on US-1. Samuel completed an interview and after being shown a six picture photo line-up positively identified the black male that carjacked him as Phillip Haire Jr.

There were three additional witnesses to the carjacking. Two of the witnesses saw the black male with a handgun and after being shown a six person photo line-up positively they identified Phillip Haire Jr as the person that carjacked Nutter. The third witness saw a black male but did not observe him carrying a firearm. When this witness was shown a 6 person photo line-up he pointed to Haire Jr's picture and stated the person that car jacked Nutter looked like the guy in the picture but did not want to give a 100% positive identification.

Based upon the investigation I am requesting Phillip Joseph William Haire Jr, be charged with Aggravated Assault with a firearm in violation of Florida State Statute 784.02(1)(a), Carjacking with firearm in violation of Florida State Statute 812.133(2)(a), Burglary while armed with a firearm in violation of Florida State Statute 810.02(2)(b), shooting into a building in violation of Florida State Statute 790.19, discharging firearm from a vehicle in violation of Florida State Statute 790.15(2), aggravated Assault on a law enforcement officer in violation of Florida State Statute 775.0823(11), attempted 2nd degree murder of a law enforcement officer in violation of Florida State Statute 782.065 and 782.04(2).
