The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the 11 day of February, 2025, at approximately 0700 a.m. p.m. at 65 Sedgwick Trail, Palm Coast, Florida 32164 within Flagler County, violated the law and did then and there:					
On May 31, 2024, at approximately 2059 hours (MV) (14 years old) was reported to have run away. MV was reported missing at this time under FCSO case #2024-00046837. It should be noted that MV is a frequent runaway.					
On June 1, 2024, at approximately 1105 hours, MV was located by family members at Holland Park. At this time, law enforcement made contact with MV and her family members, and she was in good health. MV was removed from FCIC/NCIC as missing. Shortly after closing the call for service, FCSO was notified that MV was reporting to her family that she was sexually battered while she was missing (May 31, 2024- June 1, 2024). MV was transported to Advent North (1 Adventhealth Way; Palm Coast, Florida 32137) for a sexual assault examination (SAE).

I, Detective Gordon, conducted an interview was conducted with MV at which time she advised the following:

- MV walked out of her residence last night (May 31, 2024) with a blunt and lighter. She had no other belongings and does not have a cell phone. MV walked from her residence [REDACTED] Palm Coast, Florida, to the Circle K (1500 Palm Coast Parkway NW; Palm Coast, Florida), alone.
- MV arrived at Circle K at approximately 2100-2200 hours. At this time, a passerby allowed MV to use their cell phone. MV logged into her Snapcha [REDACTED] and called Jordan Pittmon (backendchild.jp) on Snapchat. MV asked him to come pick her up.
- o MV advised that she met Pittmon through Instagram around November of 2023. MV's Instagram username is [REDACTED] and Pittmon's is backendchild.jp. At this time, Pittmon messaged her. After talking for approximately a week and planning to meet, [REDACTED] (MV's aunt) discovered the messages between MV and Pittmon and confronted Pittmon. According to the messages, MV had told Pittmon that she was 17. [REDACTED] made him aware that MV was 14 years old. [REDACTED] advised that she contacted his place of employment, Ford of Daytona, and sent them screenshots of his messages with MV.
- Pittmon arrived at the Circle K gas station (1500 Palm Coast Parkway NW; Palm Coast, Florida) in a Volkswagen SUV. MV advised that he did not exit the vehicle. MV entered the vehicle, and they drove straight to his residence. On the way to the residence, MV and Pittmon smoked a "blunt" of marijuana that she brought with her. MV recalled that Pittmon's residence was in the "S-section" but did not know the exact address.
- o The surveillance footage from Circle K was reviewed and collected as evidence. A white/light-colored Volkswagen SUV is observed arriving at the gas station and MV is observed getting into the vehicle. The driver of the vehicle did not exit.
- o According to DAVID, Pittmon's address is 65 Sedgewick Trail; Palm Coast, Florida.
- MV and Pittmon arrived at his residence and went straight to his bedroom. MV advised that they both sat on his bed, and he put something on the television.
- Pittmon asked MV if she was on birth control at which time she told him she had Nexplanon.
- MV told Pittmon that she did not think that they "should", referring to sex; but MV does not know if he heard her or just ignored her. Pittmon took off MV's pants and then his own before beginning to kiss her. Pittmon then began to engage in vaginal sex with her. MV advised that Pittmon did not use protection, and he ejaculated inside of her vagina.
- Following this, MV stayed nude while Pittmon ordered food to be delivered to the residence. At some point, MV fell asleep and woke up and the food was there. After eating and talking, Pittmon and MV engaged in vaginal sex again. No condom was used, and Pittmon ejaculated inside of her.
- Both MV and Pittmon fell asleep. At some point in the morning, Pittmon and MV awoke and began to engage in vaginal sex for the third time. No condom was used, and Pittmon ejaculated inside of her.
- Pittmon suggested that MV shower, at which time she did.
- Pittmon drove MV to Holland Park around 1100 hours on June 1, 2024, to drop her off. MV advised that she was there for a short period before being located by her aunt, [REDACTED]

It should be noted that the clothing that MV wore before and directly following the sexual activity was collected as evidence

An interview was conducted with [REDACTED] the aunt [REDACTED] stated the following:

- [REDACTED] recalled the same situation from November of 2023 with Pittmon and provided screenshots of their conversations over Facebook about MV's age.
 - On November 10, 2023, [REDACTED] messaged Pittmon on Facebook and said, "I heard you like little kids?". Pittmon responded, "...please leave me alone I would never touch a child in that kind of way wtf do I look like. The girl lied about her age and then when I was told her age she got blocked immediately I don't play that shit". Pittmon, later, responded, "I wasn't asking her to do any fucking thing and I didn't know she was 13 years old". [REDACTED] said, "she still said she was 17" and "thats a minir" before correcting herself and saying "minor". Pittmon responded, "I don't need lessons or pointers but you're right and I already spoke to god on it. Won't shit like this remotely happen again best believe. Won't even reply to random ass messages no more".
 - [REDACTED] advised that upon learning that Pittmon was with MV last night, May 31, 2024, she messaged him on Facebook to confront him. Upon learning about the sexual offense, she notified him that law enforcement was involved.

SANE Natalie Vanderhoof completed the sexual assault examination (SAE) and obtained multiple swabs from MV's body. The SAE Kit was collected by patrol deputies and turned into evidence. A processing request was completed with the Florida Department of Law Enforcement (FDLE) for the SAE and MV's underwear.


Numerous search warrants were obtained for social media applications. Upon the review of Pittmon's Snapchat search warrant return, messages were located between MV and Pittmon on May 31, 2024. In these messages, Pittmon and MV are coordinating meeting, and Pittmon picking up MV.

A search warrant was completed on Pittmon's Facebook account. According to the search warrant return, Pittmon's cell phone number is 386-333-1786. It should be noted that this is the same cell phone number for Pittmon that was located through investigative means.

On August 2, 2024, Your Affiant received FDLE's laboratory report in reference to MV's SAE kit. FDLE identified the presence of male DNA in MV's SAE kit. Due to this, a search warrant was obtained for a sample of Pittmon's DNA.

On October 23, 2024, Detective Kusek and I made contact with Pittmon. Pittmon was made aware that he did not have to speak with us. Pittmon denied knowing or having sex with [REDACTED]. A photograph of MV from the Flagler County Sheriff's Office Facebook page was shown, and Pittmon advised that he did not recognize her. Pittmon confirmed his cell phone number to be 386-333-1786 and his Snapchat and Instagram usernames to be "backendchild.jp". The DNA search warrant for Pittmon's DNA was executed.

Pittmon's DNA was submitted to FDLE to compare to the male DNA located in MV's SAE kit. According to the FDLE Biology Report, Pittmon was "included as a possible contributor to the mixed DNA profile obtained from Item 2.2" (Item 2.2: Vaginal Swabs) and the "mixed DNA profile is greater than 700 billion times more likely to occur if the sample originated from MV and Jordan Pittmon than if it originated from MV and an unrelated individual".


