
CHARGE(S):

I) DRIVING UNDER THE INFLUENCE THIRD DUI WITHIN 10 YEARS -- DIRECT FILE

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: DANIEL OSVALDO PRIOTTI on or about June 7, 2019, in the County of FLAGLER and State of Florida, unlawfully did drive or be in actual physical control of a motor vehicle while under the influence of alcoholic beverages, chemicals or any substance controlled under Chapter 893 or any combination thereof, to the extent that normal faculties were impaired, or did have a blood or breath alcohol level of .08 or higher, contrary to Florida Statutes 316.193(1); the said offense being DANIEL OSVALDO PRIOTTI's third offense and having occurred within 10 years after a prior conviction for Driving Under the Influence said prior convictions having occurred, on July 6, 2000, in Flagler County, Florida and on June 18, 2010, in Volusia County, Florida, contrary to Florida Statutes 316.193 (2)(b)1.
