Violation of Condition (9) of the Order of Probation, by failing to comply with all instructions given to her by the probation officer, and as grounds for belief that the offender violated her probation, Officer Utra Glodava states that on April 14, 2021, the offender was instructed to report to the probation office on April 15, 2021 at 9:30am and the offender did fail to carry out this instruction by not reporting as instructed.

FAILURE TO COMPLY WITH INSTRUCTIONS

Violation of Condition (9) of the Order of Probation, by failing to comply with all instructions given to her by the probation officer, and as grounds for belief that the offender violated her probation, Officer Utra Glodava states that on April 30, 2021 at approximately 2:00pm, the offender was instructed to report to the probation office on April 30, 2021 no later than 4:00pm for a drug test and the offender did fail to carry out this instruction by not reporting as instructed for a drug test.
