1) HOW VIOLATION OCCURRED:

Violation of Condition (7) of the Order of Probation, by using intoxicants to excess or possessing any drugs or narcotics, unless prescribed by a physician, and as grounds for belief that the offender violated his probation, Officer Laso states that on or about 3-7-17, the offender was in possession of a drug or narcotic not prescribed by a physician, to-wit: cocaine as shown by analysis of a urine sample obtained from the offender on 3-7-17, and confirmed by Alere Laboratories on 3-12-17.

Violation of Condition (7) of the Order of Probation, by using intoxicants to excess or possessing any drugs or narcotics, unless prescribed by a physician, and as grounds for belief that the offender violated his probation, Officer Laso states that on or about 3-7-17, the offender was in possession of a drug or narcotic not prescribed by a physician, to-wit: marijuana as shown by analysis of a urine sample obtained from the offender on 3-7-17, and confirmed by Alere Laboratories on 3-12-17.

Violation of Special Condition (18) of the Order of Probation, by failing to attend and successfully complete a batterer's intervention program, and as grounds for belief that the offender violated his probation, Officer Laso states that the offender has not completed the batterer's intervention program at Flagler Counseling as of 1-28-17, as told to Officer Laso by Nancy Russo on 1-28-17.

Note: On 2-2-17, when the defendant reported in I spoke to him about his batter's intervention treatment he said he was sorry he lied to me but he could not afford to continue going. I told the defendant that he needed to finish his treatment and if not at Flagler Counseling he had to go somewhere else. The defendant stated he was going to go to Stewart Marchman to see if they offered the classes.

2) OFFENDER STATEMENT:

The defendant denied using marijuana and cocaine so it was sent out to the lab for confirmation and came back positive.
