(1) **HOW VIOLATION OCCURRED:** VIOLATION OF CONDITION (7) OF THE ORDER OF PROBATION, (Using illegal drugs)

**Circumstances:** On 11/25/2022 Deputy Boyd responded to a possible overdose. He contacted Danielle Brown who advised she walked in on her brother, Sean Barry and he was nonresponsive, possibly overdosed. She stated before medical staff arrived Barry stood up and stated he was fine, that he had just been in a deep sleep. Barry then told Deputy Boyd he wanted to talk to him alone. Once away from his sister's presents, Barry admitted to using heroin, that he had not overdosed. Barry was observed to having pinpoint pupils in the dark and he also had slurred speech. He was placed under arrest for violating his probation for using illegal drugs.
