1) HOW VIOLATION OCCURRED:

Violation of Condition (5) of the Order of Drug Offender Probation, by failing to live and remain at liberty without violating any law, and as grounds for belief that the offender violated his probation, Officer Daniel Ford states that on or about 5/01/2015, the offender was in possession of prescription medication (type of which is yet to be determined) and several forms of drug paraphernalia. Offender was also in possession of approximately 100 rounds of 9mm bullets. The offender was warrantless arrested and charged with Violation of Probation on 5/01/2014.

Violation of Condition (7) of the Order of Drug Offender Probation, by using intoxicants to excess or possessing any drugs or narcotics, unless prescribed by a physician, and as grounds for belief that the offender violated his probation, Officer Daniel Ford states that the offender was in possession of various prescription medications for which he had no prescription as well as several forms of drug paraphernalia. The offender was arrested on 5/01/2015, for the offense of Violation of Probation by Daniel Ford, Correctional Probation Senior Officer.

Circumstances: This officer received a phone call from the brother of Cassi Burns, the homeowner and mother of the offender's girlfriend. He stated that the offender was threatening the family and dealing drugs out of the house. He feared for the safety of the family and Ms. Burns wanted the offender out of the house but was afraid to call.

On 5/01/2015, this officer, along with Officer Jacob Ely from Probation and Parole and Detective Joseph Costello of the Flagler County Sheriff's Office, conducted a search of the offender's bedroom. The following were found, confiscated and placed into evidence:

- 1) 2 scales (known to be used for weighing drugs).

- 2) Several small baggies (known to be used in the sale of drugs).
- 3) 2 prescription bottles with names unknown to any member of the home, filled with pills (type not yet known).
- 4) 1 pill grinder.
- 5) 3 marijuana pipes.
- 6) 1 small baggie with approximately 12 pills (peach in color).
- 7) 1 small clear container with an unknown crystallized substance.
- 8) Approximately 100 rounds of 9mm ammunition.

2) OFFENDER STATEMENT:

The offender stated that he had no idea who the prescription medications belonged to but did admit to the drug paraphernalia and the 9mm bullets. He stated that most of the items found in the search were moved into the home with his other possessions and he just never got around to removing them.

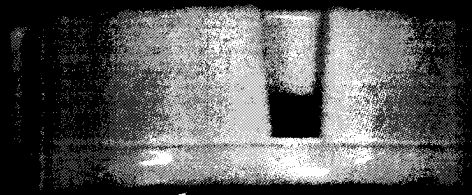

4) RECOMMENDATION:

He had no place to live and was allowed to live at the home of the offender's girlfriend's mother at 15 Richardson Drive, Palm Coast, FL. 32164. It is alleged that he has been dealing and partaking in drugs and threatening the members of the household. Therefore, this officer respectfully recommends that Your Honor revoke this offender's Drug Offender Probation and sentence him to Three Hundred Sixty-Four (364) Days in the Flagler County Jail.

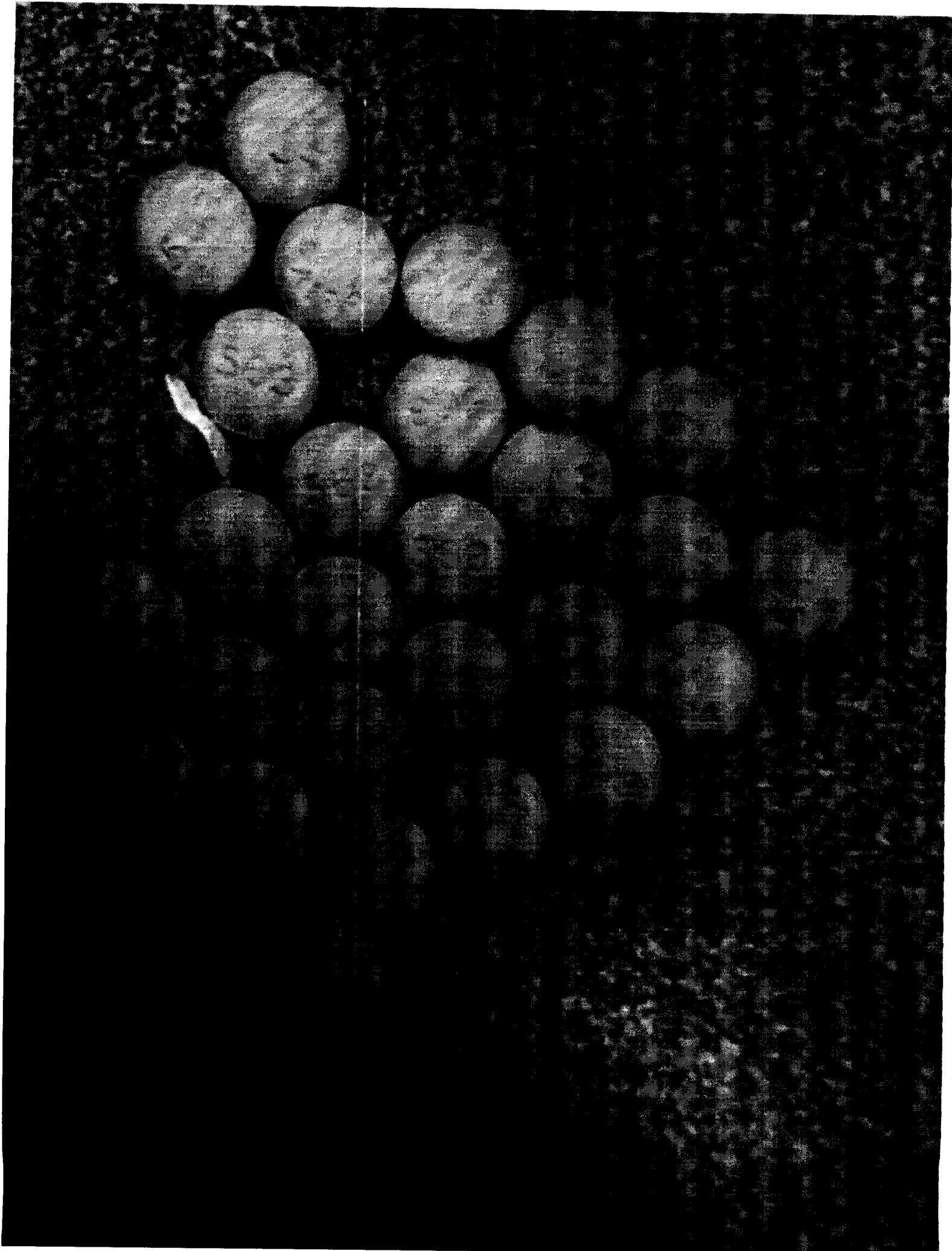
