Before me this day personally appeared NICOLE LYNN GREEN who, being first duly sworn says that JOSHUA RYAN SIEDEL hereinafter referred to as the offender was sentenced in accordance with the provisions of Chapter 948, Florida Statutes, as follows:

Affiant states that the offender was instructed on the conditions of Probation on 08/22/2025 by Officer Todd Fontaine.

Affiant further states that the offender has not properly conducted himself, but has violated the conditions of his Probation in a material respect by:

Violation of Condition (7) of the Order of Probation, by using intoxicants to excess or possessing any drugs or narcotics, unless prescribed by a physician, and as grounds for belief that the offender violated his probation, Officer Green states that on or about 09/10/25, the offender was in possession of a drug or narcotic not prescribed by a physician, to-wit: THC, Methamphetamine, and Cocaine as shown by analysis of a urine sample obtained from the offender on 09/10/25, and he signed a Positive Drug Usage Statement.

Violation of Condition (1) of the Order of Probation, by failing to report to the probation officer as directed, in that, on 08/22/2025, the offender was instructed by Officer Fontaine to report to the probation office on 09/05/25, and as grounds for belief that the offender violated his probation, Officer Green states that the offender failed to report as directed, on 09/05/25.

Violation of Condition (9) of the Order of Probation, by failing to comply with all instructions given to him by the probation officer, and as grounds for belief that the offender violated her probation, Officer Green states that on 08/22/25, the offender was instructed to report to probation on 09/05/25 and the offender did fail to carry out this instruction by failing to report on 09/05/25.

Violation of Special Condition (1) of the Order of Probation, by failing to undergo a drug/alcohol evaluation, and as grounds for belief that the offender violated his probation, Officer Green states that on 08/22/25, the offender was instructed to attend the evaluation at SMA, and as of 09/05/25 the offender has not provided any evidence that he attended an evaluation.

Violation of Special Condition (18) of the Order of Probation, by failing to undergo or complete a Domestic Violence Intervention Program, and as grounds for belief that the offender violated his probation, Officer Green states that on 08/22/25, the offender was instructed to complete a Domestic Violence Intervention Program.

Violation of Special Condition (27) of the Order of Probation, by failing to undergo a Mental Health evaluation, and as grounds for belief that the offender violated his probation, Officer Green states that on 08/22/25, the offender was instructed to attend the evaluation at SMA, and as of 09/10/25 the offender has not provided any evidence that he completed this evaluation.

Violation of Special Condition (28) of the Order of Probation, by failing to undergo a Mental Health evaluation, and as grounds for belief that the offender violated his probation, Officer Green states that on 08/22/25, the offender was instructed to attend MRT, and as of 09/10/25 the offender has not provided any evidence that he followed this instruction and signed up for/attended MRT.

Violation of Condition (5) of the Order of Probation, by failing to live without violating any law by committing the criminal offense of Criminal Mischief on 10/30/25, in Flagler County, FL, and as grounds for belief that the offender violated his probation, Officer Green states that the offender was arrested on 10/30/25, for the said offense by Deputy Bolling of the Flagler County Jail, as told to Officer Green by receipt of the Charging Affidavit.
