<p>On July 2nd, 2010, I responded to the Children's Advocacy Center in Bunnell in reference to a sexual assault for a sexual assault exam. The victim's name is [redacted] who resides at [redacted] in Bunnell with her mother [redacted] and sister [redacted]. The SANE nurse who conducted the sexual assault exam was Sherri Lademann. She also did toxicology test since [redacted] believes she may have been drugged by the suspect. [redacted] had brown discoloring under her chin which may have been from the suspect grabbing her neck. She had a scratch on her left arm and bruising on her leg which was photographed by the evidence technician Deputy David Moore who responded to the Children's Advocacy Center. The sexual assault exam was placed into evidence.</p>



After the sexual assault exam, [REDACTED] came to the Criminal Investigation's Office with her mother for an interview. According to [REDACTED] during her interview, she snuck out of her residence and met with Steven Barneski who she met on the computer/internet about two weeks ago. This was on the night of 6/28 or earlier morning hours of 6/29/2010. Steven is twenty years of age. She was dropped off back at her residence around 0300-0400 hours on the 29th of June. Steven came back to the residence with his brother about 0500-0700 hours and picked [REDACTED] up again. Steven's brother Rob was driving and Steven was in the passenger's seat. They went to Steven's residence in the "Z" section of Palm Coast (7 Zachery Place). [REDACTED] and Steven went into his bedroom and everything was fine for about a half hour. She thinks his parents and his brother was home when they first got back but then left when the incident took place. Steven locked the bedroom door then got violent. He grabbed her by her neck and slammed her head up against the wall a couple of times. He tried to French kiss her and slammed her against his bed. He took all of her clothes off and took all of his clothes off as well. He pushed her shoulders back while she was on the bed and sexually assaulted her. He put his penis in her vagina. A couple of hours later he did it again. He performed oral sex on her several times and tried to make her perform oral sex on him. She said he gave her orange juice and cookies after the incident and thinks he may have "drugged" them because she felt weird after eating and drinking. [REDACTED] said she told Steven "no" and bit his shoulder but he sexually assaulted her anyway. He did not use a condom when they had sex. She said she knew what ejaculation meant and did not know if he ejaculated. She did not think he ejaculated while he had his penis in her mouth because he didn't taste anything. He told her not to tell anyone about what happened. She stated she was scared because he called her and told her that he wanted to shoot her mother and her sister and cut their heads off. She also stated she saw a gun in his closet but he did not threaten her with it. She did not know what color it was. She said he previously sexually assaulted her on another occasion in his uncle's trailer out in Mondex. She believes the trailer is located somewhere off of Hibicus Street. She does not know his uncle's name and said no one else was there when the incident happened. This happened on an unknown date and time some time within the last two weeks. She said they went into a small empty room and he sexually assaulted her on the floor. No oral sex occurred on this day. She explained he put his penis in her vagina and no condom was used. She told him no but he pressed her shoulders against the floor and forced himself on her. She described Steven as about six foot five inches tall with a very thin build. He has no piercings. He has brown hair and green eyes. She does not know if he was doing drugs on the day of the incident. A cd copy of the interview will be placed into evidence.

Charges forwarded to the State Attorney's Office for review.
