The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the 17th day of January , 2014, at approximately 11:58 <input type="checkbox"/> a.m. <input checked="" type="checkbox"/> p.m. at Palm Coast within Flagler County, violated the law and did then and there: On Friday, January 17, 2014, at 11:58 p.m., Richard R. Kelley was operating a silver, 2003 Chevrolet Malibu 4-door, bearing Florida tag number J458RE, southbound on Belle Terre Parkway occupying the left turn lane at the intersection of Pine Grove Drive. Richard R. Kelley made an improper left turn into the path of another vehicle. The other vehicle was traveling northbound on Belle Terre Parkway occupying the left lane approaching Pine Grove Drive. V-2's front bumper struck the right side of V-1 causing V-1 to rotate counter clockwise and came to final rest on the north-east corner of Belle Terre Parkway and Pine Grove Drive facing north. V-2 rotated clockwise and came to final rest partly blocking Belle Terre Parkway's northbound right lane facing east. Richard R. Kelley was under the influence of alcoholic beverages to the extent his normal faculties were impaired, (Ethyl alcohol, 0.137 +- 0.006 g/100 mL of blood (k=3,99.7%). Richard R. Kelley's Florida Driver's License was suspended for failing to comply with traffic summons in Arkansas and Kansas. Richard R. Kelley's actions caused this traffic crash to occur, which resulted in the death of Michelle H. Roberts, the injuries to Stephanie N. Daley an to himself, and the damages to a 2003 Chevrolet Malibu and a 2013 Nissan Sentra. See Traffic Homicide Investigation Number FHP714-61-002
