		<p>I was dispatched to the Aventura Police Station to meet with the victim of a Battery. Upon my arrival, I met with [REDACTED]. She stated that earlier this date, she was a volunteer for the Miami Dolphins Organization as a hole monitor, for the annual "Fins Weekend Golf Tournament," which was held at the Turnberry Resort and Hotel. While performing her duties, she was approached by one of the Dolphins players Richie Incognito. According to her, Mr. Incognito had been drinking and was acting very inappropriate towards her. Ms. [REDACTED] states that Mr. Incognito used his golf club to touch her by rubbing it up against her vagina, then up her stomach then to her chest. He then used the club to knock a pair of sunglasses off the top of her head. After that, he proceeded to lean up against her buttocks with his private parts as if dancing, saying "Let it rain, Let it Rain!" He finally finished his inappropriate behavior by emptying bottled water in her face.</p> <p>Ms. [REDACTED] not knowing what to do, notified her sponsor or supervisor of the incident. The Supervisor then in return notified Miami Dolphin Security, who advised that they would take care of the situation. According to Ms. [REDACTED] one of the event sponsors or organizers witnessed the incident, but did nothing to help. According to [REDACTED], there were other people around that witnessed the incident, but did nothing to intervene also. She also states that Mr. Nate Moore (Former Dolphin Player) heard of the incident and came to Ms. [REDACTED] to apologize for what had taken place. He also stated that the incident would be taken care of and handled.</p> <p>Ms. [REDACTED] came to the Aventura Police Station to file a report, due to the fact that she believed nothing was being done. A formal apology would have been appreciated by Ms. [REDACTED] from Mr. Incognito, only if he had done so. She felt like he didn't care and thought the whole incident was in fun and games. Other people apologized for him, but not him.</p> <p>Ms. [REDACTED] was advised that she can direct file with the State Attorney's Office or take Civil Action.</p>
