Comments

1.1.1 Outbreaks

A. Operators are required to notify the local county health department immediately upon any suspected outbreak of communicable disease and must follow the health departments direction.

A suspected outbreak occurs when two or more children or employees have the onset of similar signs or symptoms within a 72-hour period or when a case of a serious or reportable communicable disease is diagnosed or suspected in a child or employee. Some examples include, salmonella, chicken pox, measles, and hand, foot and mouth disease. Contact your local health department for a determination of whether reporting is required

Correction of the violation occurred at the time of inspection in that during the initial complaint investigation on 2/11/2019, The director Y P was able to report the outbreak to the Health Department representative who was present with counselor at that time.

Corrective action will consist of a parent teacher meeting with the Health Department representative providing a small seminar regarding Communicable Disease Control at the facility and in the home. A written agenda of the meeting and written list of teachers in attendance will be documented at the next inspection.
