driver's seat. There was a Hispanic female in the front passenger seat who identified herself as Teresa A. Salgado but did not have any form of identification on her person. I ran Teresa through Flagler County Communications and a short time later they came back with no record found through NCIC/FCIC. I made several attempts to positively identify Teresa including Rapid ID at Flagler County Booking but was unable to identify her by the name she provided. Teresa is being listed as Jane Doe with the alias Teresa Alicia das Neves Aresta Salgado

I immediately detected an odor what is known to me through my training and experience as Marijuana emitting from the vehicle. I then requested a second unit to my location.

Upon Deputy Faircloth's arrival, I had Hannah and Teresa step out of the vehicle while I conducted a probable cause search. While Deputy Faircloth frisked Teresa for weapons, he located a scale hidden in her pant leg. During the search of Hannah's wallet (which had several forms of her identification in it), I located a small zip-lock baggie with a piece of aluminum foil that had a multi-colored square paper in it. During the search of the center console, I found 2 glass pipes and six (6) yellow round pills with the imprint (Q) and (100) on it. I identified the pills through <https://www.Drugs.com/imprints.php> as "Quetiapine Fumarate 100 Mg" and is available by prescription only. During the check of the passenger side glove compartment, I found two (2) Crown Royal bags. One of the Crown Royal bags contained a zip-lock baggie with a green leafy substance. Also inside one of the Crown Royal bags were a vape-pen with a thick brown liquid in the cartridge, 2 glass pipes, a container with a thick brown wax, a smiley face grinder, a pair of brass knuckles, and another piece of aluminum foil that had a multi-colored square paper in it.

At approximately 2124 hours, I advised Hannah of her constitutional rights from my agency issued Warning of Constitutional Rights Card. After Reading Hannah her Constitutional rights, I asked Hannah if she understood her rights as I read them to her, to which she advised that she did. The following is a synopsis of Hannah's Post-Miranda statement.

Hannah stated that the glass pipes in the center console were hers. She also advised that the above-said pills were hers and that she used them for sleeping. Hannah stated she was unaware of the items in the passenger glove compartment. Hannah stated that the aluminum foil with the multi-colored paper that was found in her wallet should be "LSD". She explained that she thought it was "LSD" when she bought but was unsure if she wanted to take it.

At approximately 2128 hours, I advised Teresa of her constitutional rights from my agency issued Warning of Constitutional Rights Card. After Reading Teresa her Constitutional rights, I asked Teresa if she understood her

rights as I read them to her, to which she advised that she did. The following is a synopsis of Teresa's Post-Miranda statement.

Teresa stated that the both Crown Royal bags were hers. She identified several items that found in the Crown Royal bags including the smiley face grinder, marijuana, and vape pen. When I asked Teresa about the folded up aluminum foil with the multi-colored paper that was found in her Crown Royal bag, she claimed she was not aware of it.

During my investigation, I conducted a field test of the green leafy substance found in the zip-lock baggie using a Lynn Peavy Marijuana Quick Check test kit, which resulted in a presumptive positive result for Marijuana. I weighed the clear zip-lock bag, which contained the green leafy substance on a scale that was placed on a level surface, which displayed weight of 29 grams including the weight of the bag. I weighed the bag independently and showed a weight of 4 grams making the total weight of the marijuana to be approximately 25 grams.

I also conducted a field test of the thick brown substance in the vape-pen cartridge using a Lynn Peavy Marijuana Quick Check test kit, which resulted in a presumptive positive result for Marijuana oil. I conducted a field test of the container with the thick brown wax using a Lynn Peavy Marijuana Quick Check test kit, which resulted in a presumptive positive result for Marijuana oil. There were also traces of a green leafy substance on the scale that was found on Teresa's person which tested presumptive positive for Marijuana.

Both pieces of multi-colored square paper that was folded inside aluminum foil will be sent to the Florida Department of Law Enforcement (FDLE) for testing.

Because of the presumptive positive test and Teresa claiming ownership, I placed Teresa under arrest for the following; Possession of hashish, Possession of Marijuana over 20 grams, and Possession of Drug Paraphernalia.

Because of the 2 glass pipes with presumptive positive marijuana residue and six (6) yellow pills that Hannah claimed ownership of but did not have a prescription for, I placed Hannah under arrest for the following; Possession of a legend drug without a prescription and drug paraphernalia.

I transported Hannah and Teresa to the Flagler County Inmate Facility without incident.

I issued Hannah Ecite citation #AABMRJE for the passenger headlight not working.

I conducted an NCIC/FCIC check of Teresa and Hannah which yielded in negative results in wants or warrants status. I conducted a check in CCIS for any previous charges of possession of Marijuana, which yielded negative
