<b>NARRATIVE</b>		The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the 12 <sup>th</sup> , 13 <sup>th</sup> , and 15 <sup>th</sup> day of January, 2019, at approximately midnight to six am on January 12 <sup>th</sup> ; midnight to six am on January 13 <sup>th</sup> ; midnight to three am on the 15 <sup>th</sup> at 6 Peyton Place, Palm Coast, FL, within Flagler County, violated the law and did then and there:			
Enter the victim's bedroom through her bedroom window on three separate nights, had penial/vaginal sex, penial/anal sex as well as oral sex. Defendant admitted to each sexual act during an interview with NCIS investigator D. Matos, post Miranda.					
Defendant stated that he met the victim on the website, "Plenty of Fish", on Saturday January 12th, (Defendant also communicated on "Snapchat" and Google "Hangouts") began talking on the phone with her and was invited to her residence, arriving at approximately midnight. Defendant entered the juvenile victim's room through her bedroom window, which she opened for him, and after a few hours of communication and kissing; they had sexual intercourse.					
Defendant came back the next evening, Sunday January 13th, again arriving at approximately midnight and entering the victim's bedroom through her window. The defendant admitted to having sexual intercourse with the victim, vaginal, anal, as well as orally.

Defendant came back on Tuesday, January 15th arriving at approximately midnight and again entering the victim's bedroom through her bedroom window. Defendant admitted to having sexual intercourse with the victim on this night as well. On this evening however, the defendant and victim were discovered by the victim's mother, after she heard them in the bedroom.

The mother stated that she discovered the victim in her bra and underwear and the defendant wearing only his boxers and attempting to hide on the floor on the opposite side of the bed.


On March 27th 2019 at approximately 0858 hours, I received a written statement from a witness, where the victim admitted to having a sexual relationship with an older gentleman named "Bo." The victim further stated to the witness that "she and Bo had sexual intercourse and he would give her massages with oil that he provided."

On Friday June 7th 2019 at approximately 1504 hours, I received an e-mail from CSI C. Woody, notifying me that the Biology report has been completed by FDLE. I then downloaded the report, which has been uploaded to the case fil, labeled "Final FDLE Lab Report, the results are reported as follows:

Using a commercial immunological assay, semen was identified on Item 2, (Cuttings from the victim's bed sheets). PCR based STR DNA analysis was performed on samples from Items 1, (Buccal swabs from Bo Sirine) and 2 utilizing the GlobalFiler PCR Amplification Kit.

A complete DNA profile was obtained from Item 1, which was then compared to DNA results from Item 2, which demonstrated the presence of a mixture consistent with two donors including at least one male contributor. Bo Sirine is included as a possible contributor to the mixed DNA profile. The observed mixed DNA profile is greater than 700 billion times more likely to occur if the sample originated from Bo Sirine and on unrelated individual than from two unrelated individuals.

A complete DNA profile consistent with a male individual was obtained from Item 2 (Sperm cell fraction). This DNA profile matches the DNA profile from Bo Sirine. The observed DNA profile is greater than 700 billion times more likely to occur if the sample originated from Bo Sirine than from an unrelated individual.
