The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the 12 day of March, 2011, at approximately 537 a.m. p.m. at Chestnut Ave at Avocado Blvd within Flagler County, violated the law and did then and there:  Def was observed by Deputy Prevatt in actual physical control of a grey 98 Jeep 4 door bearing FL tag# L882IB towing a trailer bearing FL tag #G862ZF while under the influence of alcohol or controlled substances. Deputy Prevatt advised me she was called to the scene for a person unresponsive behind the wheel possibly in need of medical assistance. Deputy Prevatt advised me she observed def. in the driver's seat passed out with his head leaning against the window and propped up with his arm. Deputy Prevatt tried to speak to def to ask if he's ok but he wouldn't respond. Deputy Prevatt had to shake def.'s arm to awaken him. Deputy Prevatt stated she smelled the odor of alcohol on def's person and observed his eyes to be bloodshot. When def. exited his vehicle he was unsteady on his feet. Deputy Prevatt requested a supervisor. Cpl. Fink then requested I respond. Upon my making contact with def. he was standing outside the vehicle. I observed him to sway while standing. I observed def's eyes to be blood shot and glossy. Def's speech was slurred and thick tongued. While speaking to def. I smelled a moderate odor of alcohol on his breath. I told def that I was conducting a criminal investigation for DUI and asked him to perform field sobriety exercises. He voluntarily complied.  I asked def to perform the following exercises which he did: Horizontal Gaze Nystagmus: Def swayed while standing, def had a lack of smooth pursuit in both eyes and onset of nystagmus prior to 45 degrees in both eyes. Def had to be reminded to keep his head still and follow my pen with his eyes only.  Walk and turn: touched heel to toe the first 9 steps and the last 9 steps. Def failed to watch his feet as instructed.
