Lane. The vehicle is described as a cream colored convertible Mitsubishi Eclipse bearing a Florida License Plate number of BPVC66, and was partially blocking the roadway with the window open and the door slightly ajar. The vehicle was facing south bound.

Seeing that the vehicle was illegally parked, and that the window and door were partially opened, and that the vehicle was parked in front of a wooden lot, I found it suspicious and approached the driver's side door. Upon approaching the driver I met the suspect, Sophia Zhudro. I asked Ms. Zhudro if she was ok and explained the reason why I had stopped out with her vehicle. I could immediately smell a strong odor of freshly burnt marijuana coming from inside of the vehicle. Observing that Ms. Zhudro had an infant in the rear passenger seat, I asked her to step out of the vehicle to continue my investigation away from the infant. I asked Ms. Zhudro if she had marijuana in the vehicle to which she replied that [REDACTED]

[REDACTED] Ms. Zhudro then began pleading with me not to take her to jail and started moving towards the front driver's seat. For officer safety, the safety of Ms. Zhudro and her child, I then asked Ms. Zhudro to sit in the rear of my marked patrol vehicle until I could complete my investigation.

Detective Costello arrived at the scene and assisted on the stop. Detective Costello read Ms. Zhudro her Miranda Warnings. Ms. Zhudro agreed to speak to law enforcement officers without legal representation. Post Miranda, [REDACTED]

[REDACTED] The infant, [REDACTED] was then given to Ms. Zhudro to hold while I conducted a search of the vehicle. A search of the car seat where [REDACTED] had been sitting resulted in the discovery of an orange and black marijuana pipe, marijuana wrapped in a clear plastic bag, (under 20 grams), and a blue lighter recovered from inside the car seat, (within the area in-between the actual seat and stand). Upon finding the marijuana and drug paraphernalia within the car seat where her infant had just been sitting, I asked Ms. Zhudro to hand me [REDACTED] so that we may arrest her and properly secure her. Ms. Zhudro refused to hand over [REDACTED] and moved to the center area of the rear seat in order to prevent us from reaching in to take possession of the infant. Ms. Zhudro finally agreed to exit the vehicle but continued to refuse to give me possession of her infant. I explained to Ms. Zhudro numerous times that she was being arrested, and needed to give us [REDACTED] so that we could arrange proper placement and security for the child. Ms. Zhudro continued to resist our commands by holding the infant even tighter in her arms. After numerous

attempts to reason with Ms. Zhudro, and through the use of three deputies, we were able to secure the infant and Ms. Zhudro by grabbing her arms and safely prying her arms off the infant while another deputy secured [REDACTED]

Ms. Zhudro stated she could not understand what she did wrong, or why she was being arrested. Ms. Zhudro acknowledged that she knew marijuana use is illegal in Florida, but through that her arrest was unjust as it was just a matter of time until the State of Florida legalized its recreational use. Ms. Zhudro stated that she didn't feel she was putting her child's life in any danger by smoking marijuana and operating a motor vehicle, or smoking marijuana with her infant child. Ms. Zhudro stated that she had smoked marijuana around 0700 hours when she woke up and had been driving around with the marijuana, marijuana pipe and lighter in the car seat with her child within in for the majority of the morning. Ms. Zhudro stated that she got the marijuana from a friend, but did not know his name and stated he wasn't a "close friend". Ms. Zhudro also has a [REDACTED] child which she took to school earlier in the morning.

Based on Ms. Zhudro's comments, the recovered marijuana pipe and marijuana, as well as the danger Ms. Zhudro placed her child, both by the placement of the drugs, and her resisting of law enforcement officers, Ms. Zhudro was arrested for Possession of Marijuana, under 20 grams, Possession of Drug Paraphernalia, Child Abuse, and Resisting Arrest without Violence.

Ms. Zhudro was then transported to the Flagler County Inmate Facility without incident.
