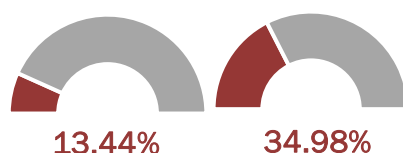

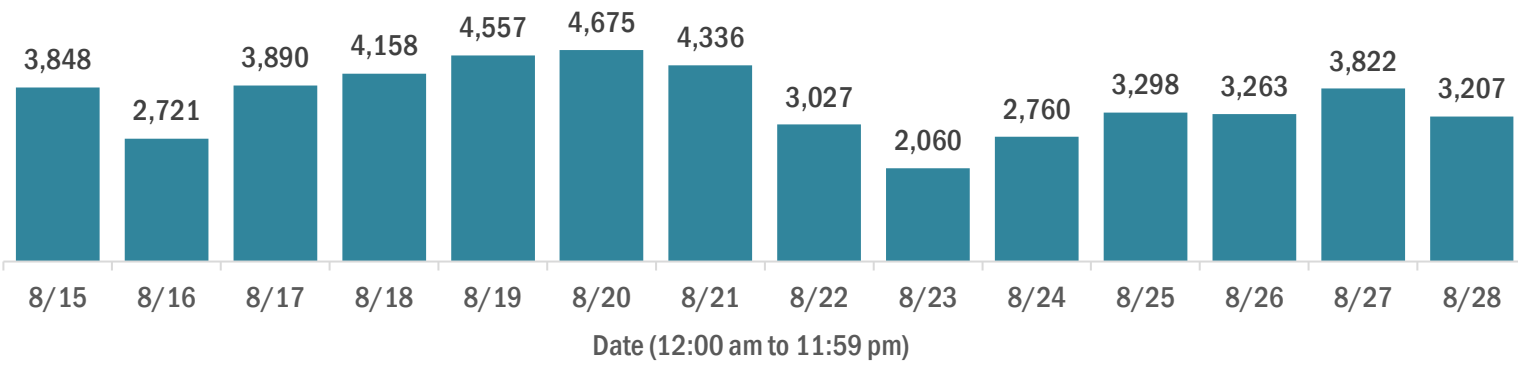
COVID-19: cases and laboratory testing over time

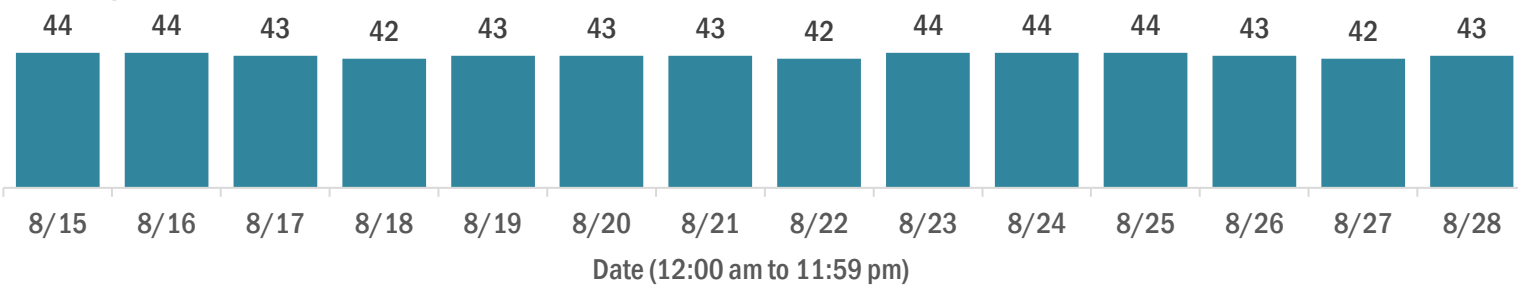

Number of cases per day



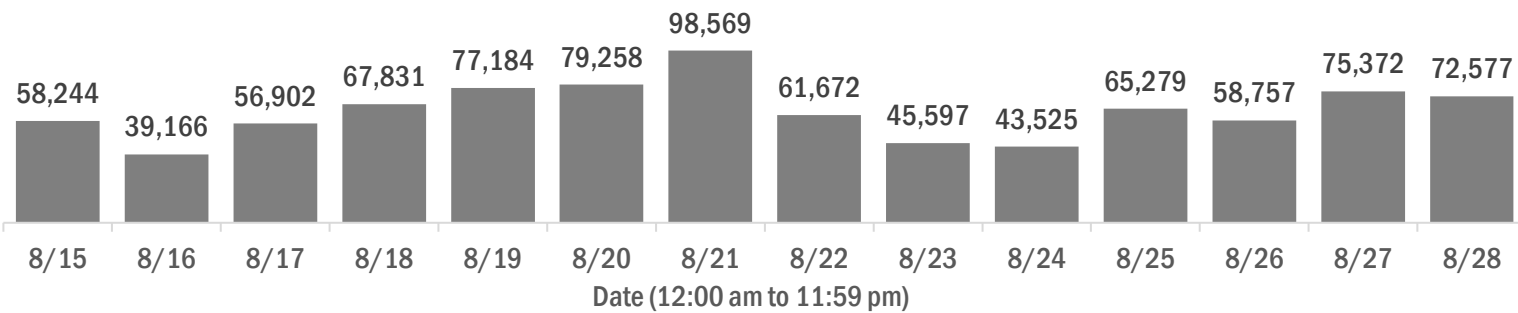
Median age of cases by day

Number of Florida residents tested per day

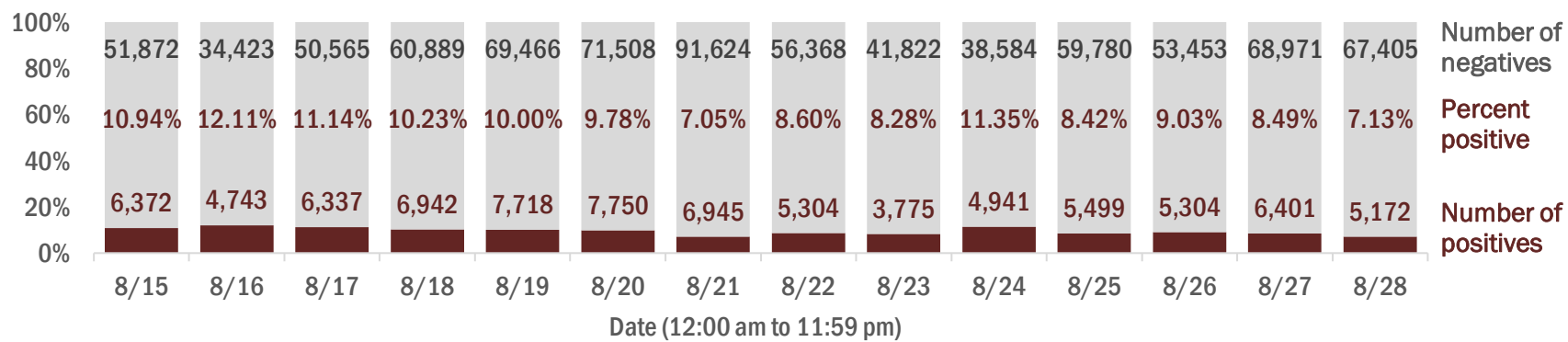

The percent of positive results ranged from 7.05% to 12.11% over the past 2 weeks and was 7.13% yesterday.

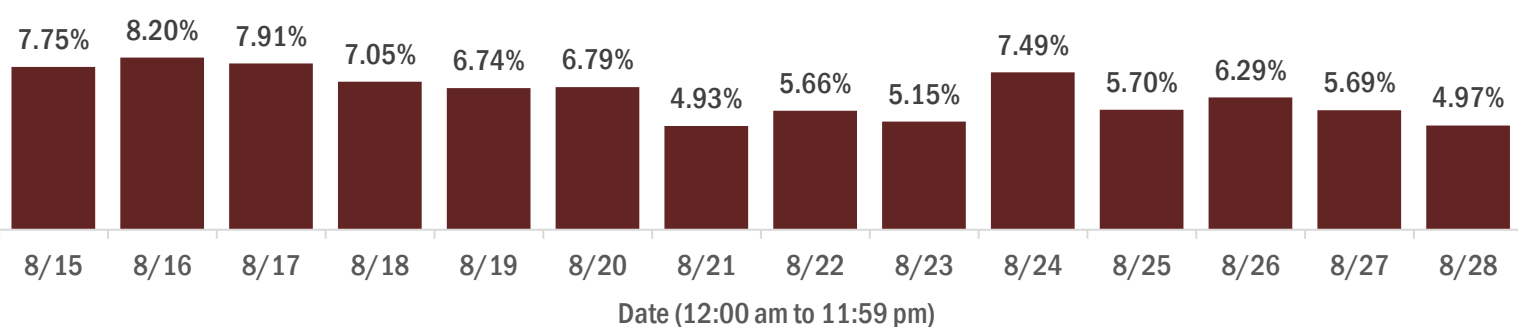

A person is only counted once for each day they are tested, regardless of whether multiple specimens are tested or multiple results are received. If a person has a positive specimen and a negative specimen in the same day, only the positive result is counted.



Percent positivity for new cases in Florida residents

The percent of positive results ranged from 4.93% to 8.20% over the past 2 weeks and was 4.97% yesterday.

This percent is the number of people who test PCR- or antigen-positive for the first time divided by all the people tested that day, excluding people who have previously tested positive.

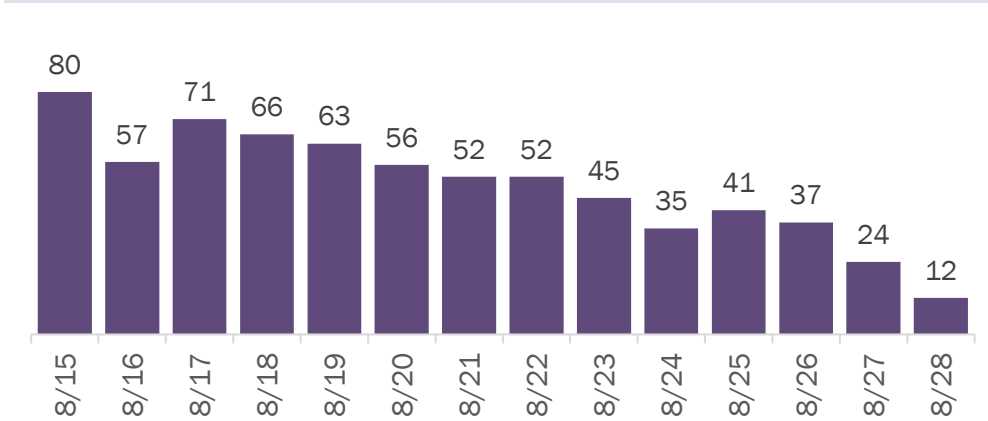

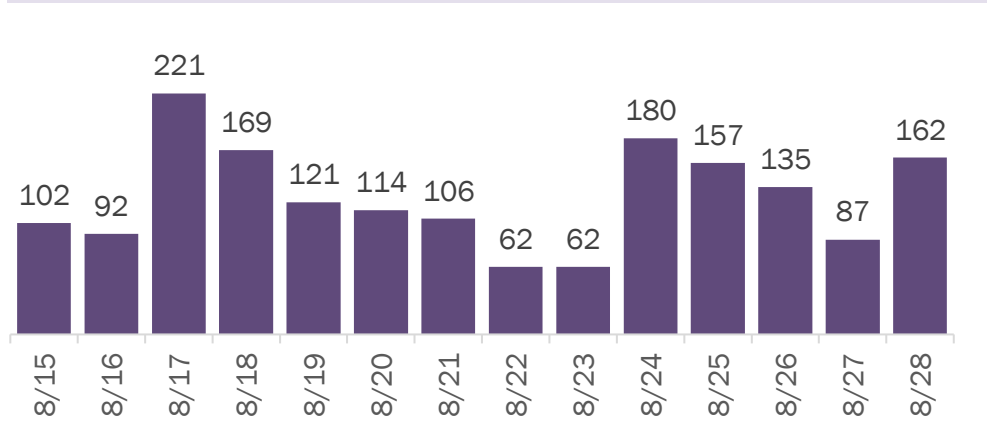

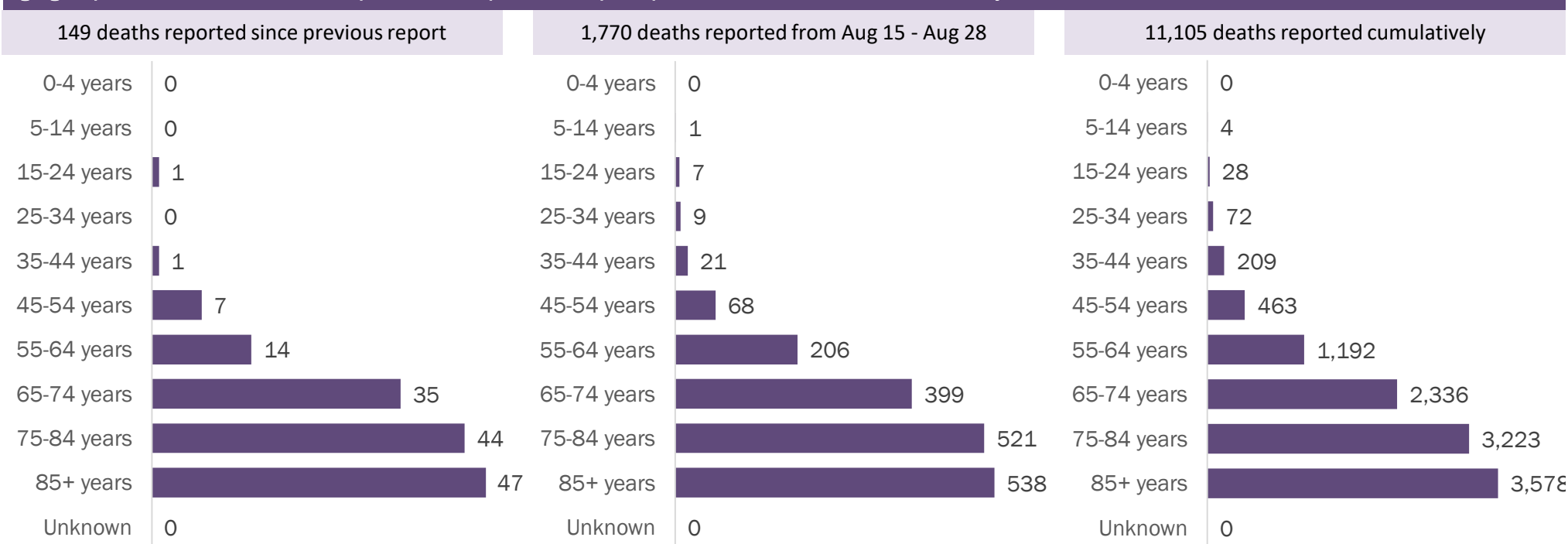

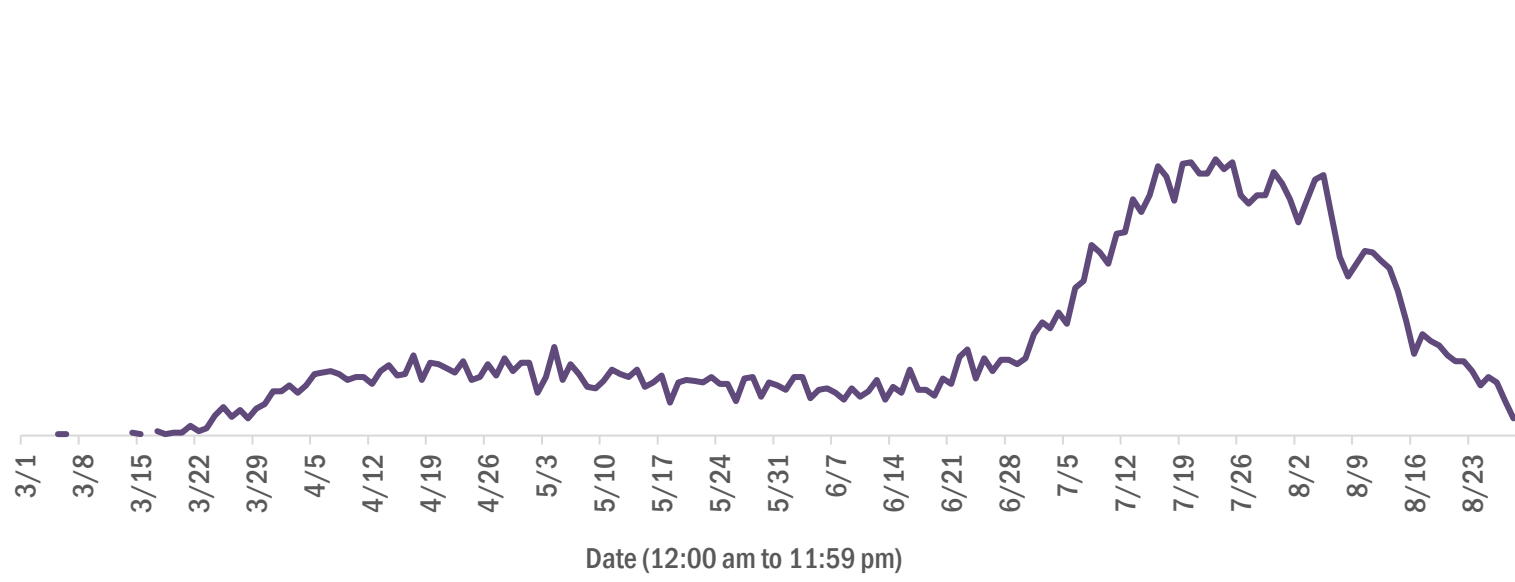

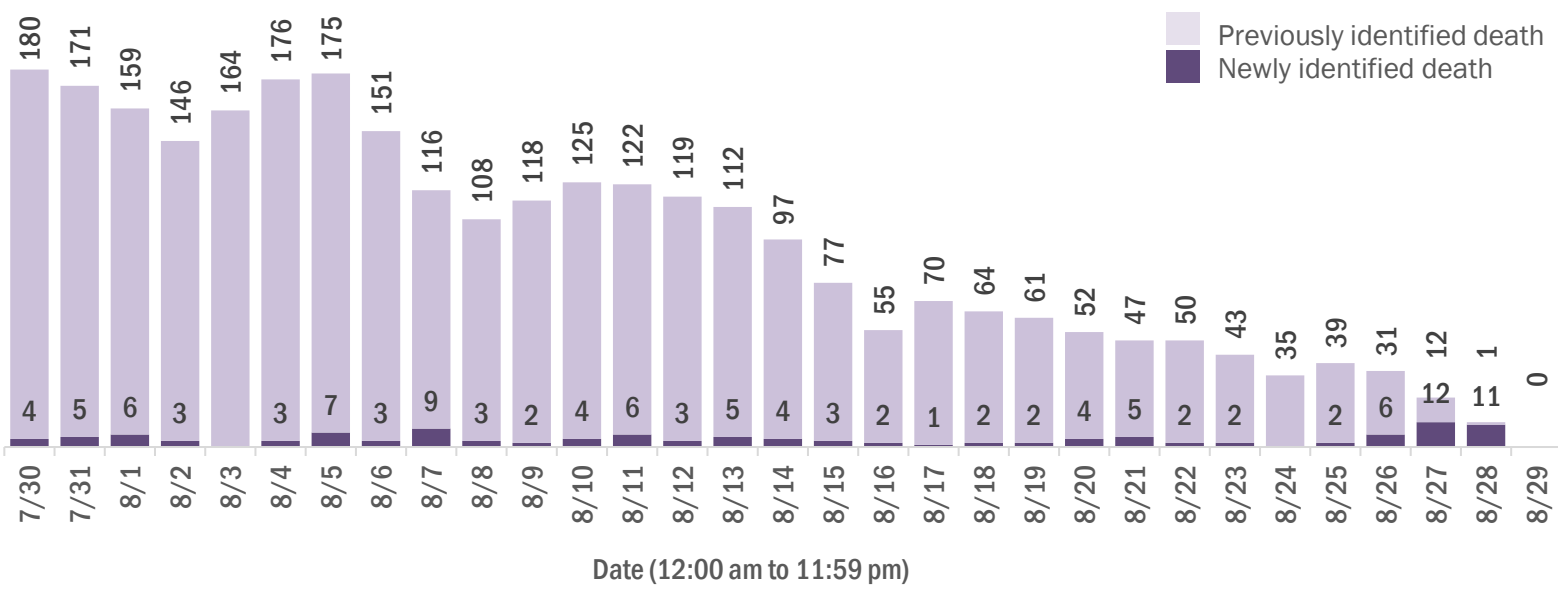
Deaths in Florida residents by date of death

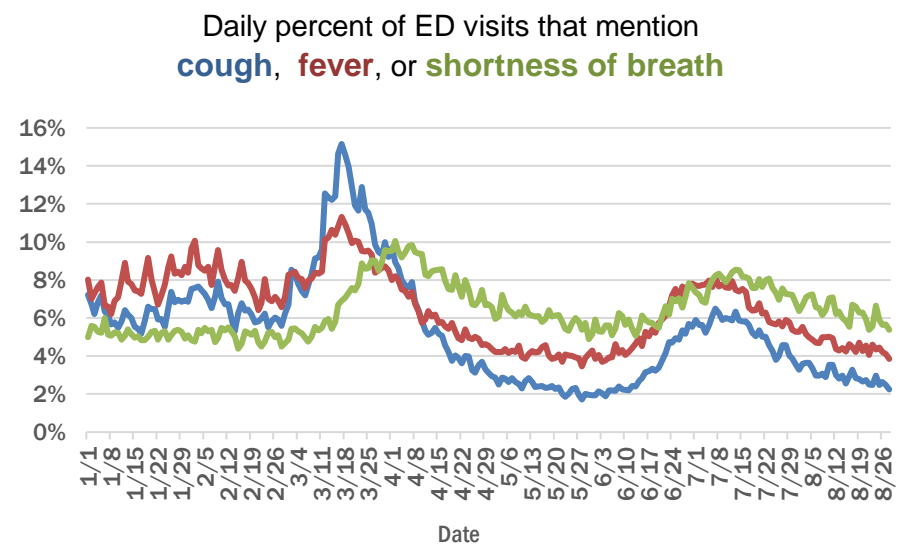
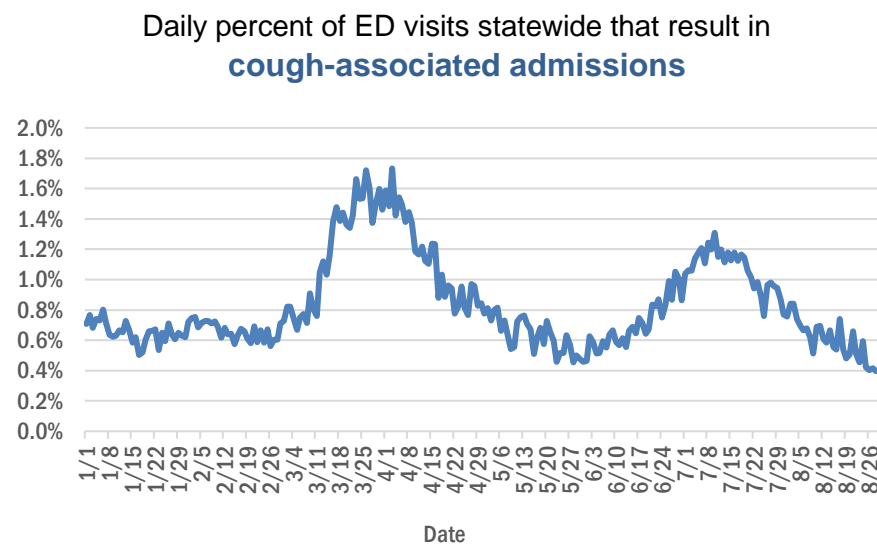

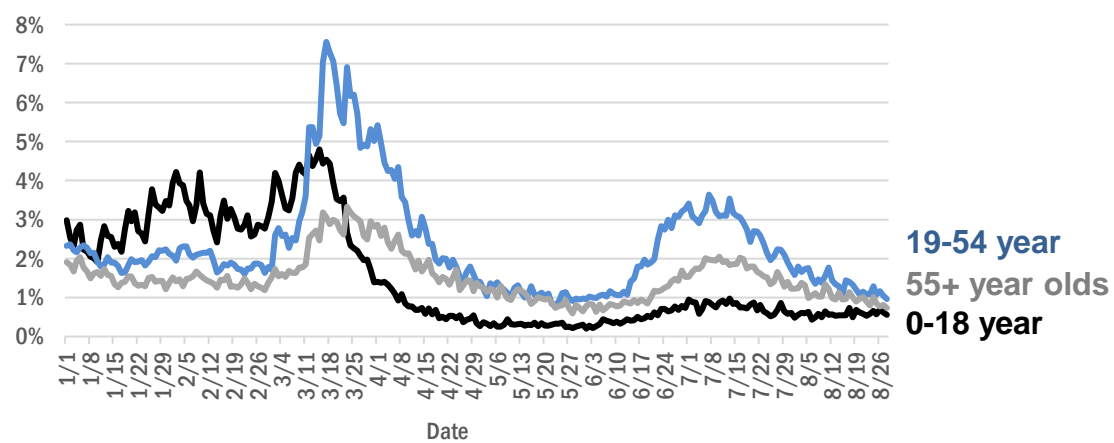
