
R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: MICHAEL GERARD STAVRIS, II, on or between April 27, 2013 and June 10, 2013, in the County of FLAGLER and State of Florida, did knowingly compile, enter into, or transmit, by use of a computer any notice, statement, or advertisement of D.M.B.'s, a minor, name, telephone number, place of residence, physical characteristics, or other descriptive or identifying information for purposes of facilitating, encouraging, offering, or soliciting sexual conduct of or with M.M., a minor, or the visual depiction of such conduct, contrary to Florida Statute 847.0135(2)(a). (3 DEG FEL)

COUNT II: MICHAEL GERARD STAVRIS, II, on or between June 10, 2013 and October 22, 2013, in the County of FLAGLER and State of Florida, did knowingly compile, enter into, or transmit, by use of a computer any notice, statement, or advertisement of D.M.B.'s, a minor, name, telephone number, place of residence, physical characteristics, or other descriptive or identifying information for purposes of facilitating, encouraging, offering, or soliciting sexual conduct of or with M.R., a minor, or the visual depiction of such conduct, contrary to Florida Statute 847.0135(2)(a). (3 DEG FEL)

COUNT III: MICHAEL GERARD STAVRIS, II, on or between November 25, 2012 and November 28, 2013, in the County of FLAGLER and State of Florida, did willfully and without authorization fraudulently use, or possess with the intent to fraudulently use, personal identification information concerning D.M.B. without first obtaining the consent of D.M.B., contrary to Florida Statute 817.568 (2)(a). (3 DEG FEL)
