

COMES NOW the undersigned Affiant, a peace officer under the laws of the State of Texas, after having been duly sworn on oath, deposes and says that I have good reason to believe and do believe that SEAN DOUGLAS STERN committed the offense of AGGRAVATED SEXUAL ASSAULT CHILD as charged in the complaint to which this Affidavit is attached and that my belief in the foregoing is based on the following information.


I MICHAEL TERPSTRA, AM A CERTIFIED PEACE OFFICER FOR THE STATE OF TEXAS CURRENTLY EMPLOYED WITH THE TEMPLE POLICE DEPARTMENT, BELL COUNTY, TEXAS. PURSUANT TO MY DUTIES, I'VE BEEN ASSIGNED TO AN INVESTIGATION INTO A REPORT OF AGGRAVATED SEXUAL ASSAULT CHILD IN WHICH THE SUSPECT IS SEAN DOUGLAS STERN. PURSUANT TO THIS INVESTIGATION I HAVE REVIEWED ALL OFFENSE REPORTS AND WITNESS STATEMENTS MADE IN CONNECTION WITH THIS INVESTIGATION.

I WOULD ADVISE THAT ON APRIL 7, 2017, I, AFFIANT MET WITH (DOB: 11- -1990) WHO REPORTED THAT WHEN COUNTY TEXAS. STATED THAT STERN'S FAMILY AND 'S FAMILY ATTENDED THE SAME CHURCH AND THAT THEN STERN, WHO WAS ABOUT TEN YEARS OLDER THAN HE, WAS A VERY GOOD SOCCER PLAYER, AND THAT WHEN WAS TEN YEARS OLD, HE BEGAN TO TRAIN WITH STERN TO BECOME A BETTER SOCCER PLAYER HIMSELF. STATED THAT AT THAT TIME, STERN WAS IN COLLEGE AND THAT WOULD TRAIN WITH HIM WHEN STERN CAME HOME FROM COLLEGE. ADDITIONALLY, STERN RECALLED THAT STERN TORE HIS ACL HIS FRESHMAN YEAR IN COLLEGE AND WAS HOME FOR A WHILE RECOVERING, AND THAT WOULD TRAIN WITH STERN AND HANG OUT WITH HIM DURING THAT TIME AT STERN'S HOME. STATED THAT STERN WAS HIS TEACHER, PRSONAL TRAINER, AND HE CONSIDERED HIM HIS "IDOL." WOULD BE ALONE WITH STERN IN STERN'S HOME WATCHING SOCCER ON TV WHEN STERN AND WOULD START TO WRESTLE. NOTICED THAT WHEN THEY WOULD WRESTLE STERN'S PENIS WOULD BECOME AROUSED AND HE LEARNED THAT IT WAS A "WEAK SPOT," AND THE ONLY WAY HE COULD WIN THE WRESTLING MATCH WAS TO GRAB AND BEND STERN'S PENIS TO MAKE HIM "TAP OUT." DURING THESE WRESTLING MATCHES, STERN AND 'S CLOTHES WOULD EVENTUALLY COME OFF AND THEY WOULD BE WRESTLING IN THE NUDE. STATED THAT ONCE THEIR CLOTHES CAME OFF, THE WAY A PERSON WOULD "WIN" THE MATCH WAS TO STICK HIS PENIS IN THE OTHER PERSON'S ANUS. STATED THAT SINCE STERN WAS SO MUCH BIGGER AND STRONGER THAN HE, COULD BARELY EVER WIN, BUT THAT HE WAS ABLE TO WIN ONE TIME BECAUSE STERN LET HIM. STATED THAT HE REMEMBERS HOLDING STERN DOWN AND CAUSING HIMSELF TO GET AN ERECTION BEFORE STICKING HIS PENIS INTO STERN'S ANUS ABOUT HALFWAY AND THEN PULLING IT OUT BECAUSE HE HAD WON. STATED THAT TO HIM IT WAS ALL A GAME AND HE DID NOT REALIZE WHAT WAS REALLY GOING ON, UNTIL ONE TIME STERN PINNED DOWN AND STUCK HIS AROUSED PENIS INTO 'S ANUS AND FELT A WET SUBSTANCE ON HIS ANUS. STATED THAT HE NOW KNOWS THAT STERN HAD EJACULATED INSIDE OF HIM, BUT THAT STERN HAD TOLD HIM AT THE TIME THAT IT WAS "JUST A LITTLE BIT OF PEE." STATED THAT WHEN HE WENT INTO THE BATHROOM TO CLEAN UP, HE DID NOT KNOW WHAT THE SUBSTANCE WAS, BUT HE KNEW THAT IT WAS NOT PEE BECAUSE IT WAS STICKY, AND WAS SUDDENLY OVERCOME WITH A FEELING THAT WHATEVER JUST HAPPENED WAS COMPLETELY WRONG. STATED THAT HE NO LONGER WANTED TO HANG OUT WITH STERN AND THAT AFTER THAT LAST INCIDENT, HE WAS NEVER WITH STERN ALONE AGAIN. 'S MOTHER, PROVIDED A STATEMENT ADVISING THAT SOMETIME IN 2015, HAD TOLD HER THAT STERN WAS A PEDOPHILE AND THAT HE HAD MOLESTED HIM WHEN HE WAS A CHILD, BUT THAT HE DID NOT WANT TO REPORT IT AT THE TIME. STATED THAT THE STERN AND FAMILIES HAD BEEN FRIENDS FOR THIRTY YEARS AND SHE REMEMBERS THAT WOULD HANG OUT WITH STERN TO PLAY AND WATCH SOCCER TOGETHER WHEN WAS A CHILD. 'S FATHER, PROVIDED A STATEMENT THAT ADVISED HIS SON TOLD HIM THAT WHEN HE WAS A CHILD HE AND STERN WOULD WRESTLE NAKED AND THAT HAD BEEN PENETRATED BY STERN'S PENIS. ALSO STATED THAT IT WASN'T UNTIL LEARNED THAT STERN HAD BEEN ARRESTED IN FLORIDA FOR SIMILAR ALLEGATIONS OF MOLESTING CHILDREN THAT HE DECIDED TO COME FORWARD AND REPORT WHAT STERN HAD DONE TO HIM.

WHEREFORE, PREMISES CONSIDERED, YOUR AFFIANT REQUESTS THAT A WARRANT ISSUE FOR THE ARREST OF THE SUSPECT IDENTIFIED ABOVE FOR THE FELONY OFFENSE DESCRIBED ABOVE
