I removed the driver out of the vehicle, Tyler Sweeney, read him his Miranda Rights, to which he advised he understood and was willing to speak with me. Tyler advised that he did in fact have marijuana in the vehicle, which he advised was in the front door console. Tyler further advised that the nectar collector was in fact his and he uses it to smoke hashish "Dab", which he was unsure if any was in the vehicle or not.

A search of the vehicle yielded a plastic baggy containing a green leafy substance in the front door side console. A nectar collector on the back seat (drug paraphernalia). A digital scale in Tyler's back-pack (drug paraphernalia). A yellow oily substance on wax paper was located in the center console. A semi-automatic black in color Glock 41, bearing serial # XRZ090, was located in the glove compartment with an extended (25) round .45 caliber magazine next to the Glock. A second (13) round .45 caliber magazine was located in Tyler's backpack on the back seat.

I field tested the green leafy substance utilizing a Marijuana Quick Check Test Kit and received a presumptive positive reaction for marijuana. I field tested the yellow oily substance utilizing a Marijuana Quick Check Test Kit and received a presumptive positive reaction for marijuana. Tyler advised that he just purchased the marijuana and dab for \$120.00, not providing any further information.

Tyler advised that the firearm does not belong to him, however, he keeps it in the car for his safety. Tyler was unable to provide information on who the gun belongs to, so the gun was taken for safekeeping. The marijuana weighed out to be 19.54 grams (bag weight). The Hashish weighed out to be 1.63 grams.

Tyler was placed under arrest for possession of Hashish, possession of marijuana under twenty grams and possession of drug paraphernalia. Tyler was transported to the Flagler County Inmate Facility without further incident. All narcotics and the firearm were later submitted to evidence.
