

The victim was walking away when the defendant pushed him in the back and hit him over the head with what the victim believes the butt of the gun. The victim walked away after being hit.

After the defendant was interviewed by Det. Taylor the defendant was outside and I advised the defendant he was under arrest. ~~th~~ I placed my hand on the defendant to affect the arrest and he pulled his hand away and back away from me. Det. Taylor and I stated to the defendant several times he was under arrest and he would not comply. At this time I deployed my X-26 ECD. While on the ground det. Taylor placed a cuff on and he would not comply. I advised him I would ~~use~~ Taser him again and after several warnings he complied.


