Case Narrative

On Friday, March 19th 2021, at 2200 hours, I Deputy Doggett responded to 5500 SR 100 E in reference to a crash with no injuries. Upon arrival I made contact with Deputy Hill who advised me that two juveniles who occupied a white tesla bearing South Carolina tag PSL632 had backed into his vehicle. I made contact with the two occupants and they identified themselves as was in the front passenger seat and was sitting in the back seat on the driver's side. stated to me that she was 15 years of and age and explained that she was fourteen years of age. advised they were coming from Charleston South Carolina and were on their way to fathers house in West Palm Beach, Florida. Both females were asked as to who was operating the motor vehicle and they stated that the vehicle was a Tesla and operated itself with auto pilot. I spoke with first and she advised me that they coming from a gas station and on their way to the crash was in the front driver's seat of the car. explained that after she removed herself from the front seat of the car and sat in the back while the vehicle was still moving. The vehicle drove in an opposite lane of traffic and then backed in Deputy Hills vehicle upon him observing it travel into the wrong lane. stated that they were traveling from the Wawa gas station located at 5600 SR 100 E and went west on SR advised that was in the back seat the entire time and then changed her story advising that 100 E. Jade was in the front seat until the vehicle traveled into the wrong lane. mother, Jennifer Crummie who resided in South Carolina, she stated that she was unaware of her daughter leaving the state and believed that she was at her grandmother's house. Jennifer advised that she would be unable to pick up this evening due to the distance and time. We were unable to make contact parents on scene due to her not providing any accurate information about her parents. Contact was made with the Department of Children and Families, contact was made with Brittany ID# 443 who advised that she would be taking a report and sending an investigator to law enforcement for assistance. A notification was sent to South Carolina to make contact with Aiyana's parents due to her not providing information and her mother Michelle White contacted the Sheriff's Office via phone. Michelle was advised of whereabouts and was also advised that law enforcement would be contacting the Department of Children and Families to respond. The two juveniles were secured in my agency vehicle for transport and upon search of their bags due to transport I found a green leafy substance in a bag, a cigarette and a small container of what appeared to be pepper spray. All of the above items were seized and will be submitted into evidence for destruction. The juveniles were transported to the Flagler County Palm Coast Sub-station to meet with the Department of Children and Families Investigator Crystal. The juveniles were turned over to Crystal. Nothing further.
