

[Text Now, is a VoIP (voice over internet protocol) service that allows users to text message and call any number in Canada and the United States.]

[An IP (internet protocol) address is a numerical label assigned to each device connected to a computer network that uses the "Internet Protocol" for communication.

IP address 75.112.73.57 is issued to the Flagler County Board of County Commissioners through Charter Communications. IP address 75.11.73.57 is used for the connection to the "Netmotion mobility" server for the

Flagler County Sheriff's Office. The exclusive user of the IP address in question, are Flagler County Sheriff's Office Netmotion mobility users. The general public does not have access to the IP address in question.

In order to access the IP address in question, one must have a Netmotion account, and access it via the Flagler County Sheriff's Office Active Directory, as well as a two factor authentication device (Yubikey) to access the server.]

### TIMELINE

On 6/3/2019 at approximately 5:40 AM, Dedorius Varnes, logged onto his Flagler County Sheriff's Office agency issued computer. This was logged on the "Netmotion mobility events log". "Netmotion mobility" at the Flagler County Sheriff's Office uses IP address 75.112.73.57.

On 6/3/2019 at approximately 7:37 AM (11:37 UTC) "Text Now" phone number (386) 463-3857 was created using register IP 75.112.73.57.

On 11/27/2019, Flagler County Sheriff's Office Patrol Deputy Dedorius Varnes responded to the area of [REDACTED] regarding a crash. The case number for the crash is Flagler County Sheriff's Office 19-109503. The reporting party (C.P.) reported that a vehicle (operated by Bryan Cranford) struck her mailbox. There is no record of Dedorius Varnes activating his Axon body camera during this incident. The incident was changed from a motor vehicle accident to a civil incident.

On 11/28/2019, the victim [REDACTED] (the husband of C.P. and a resident of [REDACTED] Palm Coast) filed an online complaint on Dedorius Varnes with the Flagler County Sheriff's Office. In the complaint, [REDACTED] explained that he did not feel as though Dedorius Varnes handled the call for service on 11/27/2019 (19-109503) sufficiently.

On 12/2/2019, Dedorius Varnes supervisor, Greg Tietje was made aware of the complaint against Dedorius Varnes by Flagler County Sheriff's Office Internal Affairs Manager Randy Doyle. Greg Tietje asked Dedorius Varnes to follow up and to rectify the issue.

On 12/2/2019, Dedorius Varnes called [REDACTED] regarding incident number 19-109503. There is no record of Dedorius Varnes activating his Axon body camera during this phone call. According to [REDACTED], Dedorius Varnes

called him, and indicated to him that he was wrong about his complaint. [REDACTED] advised that he hung up on Dedorius Varnes.

On 12/16/2019 at approximately 9:28 AM, [REDACTED] received a text message from phone number (386) 463-3857 to his cellular phone number (386) 235-5108. [REDACTED] stated that he was not familiar with this number.)

The initial text messages sent from (386) 463-3857 to [REDACTED] intimated that the sender and C.P. had been involved in a sexual relationship. The sender referred to [REDACTED] as "pussy boy".

The response from [REDACTED] was extremely angry and threatened to harm the sender, referring to the sender in an offensive term several times.

The response from (386) 463-3857 referred to C.P.'s private parts, and indicated that the sender wears [REDACTED] clothing while he is at work. The sender also threatened to have sexual relations with the [REDACTED] wife again.

On 12/16/2019 at approximately 12:16 PM, the sender sent [REDACTED] C.P.'s phone number, as to add credibility to the sender's claims of a sexual relationship.

On 12/16/2019 at approximately 12:32 PM, the sender sent [REDACTED] C.P.'s full name (unique spelling)/date of birth, and tells [REDACTED] that C.P. enjoys "long walks on the beach while her pussy boy husband is at work". The sender then continued to intimate that he will have sexual relations with [REDACTED] wife.

On 12/16/2019 at approximately 12:45 PM, the sender told [REDACTED] that his wife loves "bigger dick BBC".

On 12/16/2019 at approximately 1:02 PM, the sender told [REDACTED] his [REDACTED] address, in another apparent attempt to add credibility to the sender's claim of a sexual relationship with C.P..

On 12/16/2019 at approximately 2:58 PM, the sender called [REDACTED] a "hoe" and the conversation ends for the day.

On 12/17/2019 at approximately 6:52 AM, the sender told [REDACTED] to "wake up pussy boy", reigniting the conversation (which appeared to have ended approximately 16 hours prior).

Between approximately 8:04 AM and 8:10 AM, [REDACTED] attempted to call the sender numerous times, and from several numbers in an effort to identify the sender.

[REDACTED] threatened harm to the sender, and then tells the sender to "STOP" in all capital letters.

On 12/17/2019 at approximately 4:46 P.M., the sender tells [REDACTED] "Lol stop crying little pussy boy" followed by "Stop having all them fuck ass numbers call my phone lil bitch", followed by asking [REDACTED] where his wife is.

[REDACTED] responded, and told the sender that his wife is home.

On 12/17/2019 at approximately 5:49 PM, the sender sent a photograph to [REDACTED] of his [REDACTED] and C.P.'s residence and stated "I know". The photograph appeared to be taken from approximately 30-40 yards east of the [REDACTED] residence. The sender then asked "You still gonna cut my throat???"

[REDACTED] then responded by saying, "Yea...come back".

On 12/17/2019 at approximately 5:52 PM, the sender sent the following messages to [REDACTED]

"Lol if your gonna kill me I gotta defend myself so let the games begin" followed by "Dont get scared now you little bitch you wanna go to war and sout ou(t) racial shit then lets do it". The messages were followed by a photograph which appears to have been taken from approximately ten (10) yards east of [REDACTED] and C.P.'s residence.

On 12/17/2019 at approximately 6:14 PM, the sender texted [REDACTED] "Sleep with 1 eye open bitch".

On 12/17/2019 at approximately 6:15 PM, [REDACTED] reviewed the surveillance footage from outside of his residence, and saw that a law enforcement patrol vehicle (white Ford Taurus with a light bar) had passed his house twice in a short period, and was in the same areas where the photographs that he had just received were taken from.

On 12/17/2019 at approximately 6:18 PM, [REDACTED] told the sender that he had the sender on surveillance camera. This led the sender to respond with "Lol I just came by again ima see you later".

On 12/17/2019 at approximately 7:08 PM, [REDACTED] advised that he sender that he knew the senders identity, and called the sender "Mr. Varnes". On 12/18/2019 at approximately 8:38 AM, the sender told [REDACTED] "I saw u leaving this morning for work lol"

On 12/18/2019 at approximately 9:07 AM, the sender told [REDACTED] "Call the police you little bitch and make sure you show them you racist texts pussy boy matter fact how about I expose these texts with a picture of you and (C.P.) attached that way the whole community can see the little racist you are or even better how about I contact your job and show these texts with your name attached you little bitch I could fuck up your life in so many ways" followed by "I guess your scared and dont want to get exposed huh lol apologize for the racial slurs or I'm gonna post everything from and anonymous account and send to your job"

There are no more text messages between [REDACTED] and the sender after this. [REDACTED] was afraid to contact law enforcement to report this because of the fact that filing his initial complaint on Dedorius Varnes was the genesis of the threats and harassment.

On 7/2/2020 at approximately 6:20 PM I, Corporal Hristakopoulos, was contacted by Sergeant Miller regarding an incident in which Deputy Dedorius Varnes was suspected of committing several criminal acts. Sergeant Miller asked me if I would be willing to work on the case, beginning on 7/3/2020. I was briefed on various different aspects of the case in question. Sergeant Miller requested that on 7/3/2020, I contact [REDACTED] and gather a sworn statement from him.

On 7/3/2020 at approximately 1:00 PM, I made contact with [REDACTED], who provided me with a sworn audio recorded statement regarding the incident in question. [REDACTED] showed me the text messages in question, which were still on his cellular phone, and they were video recorded.

On 7/3/2020, I responded to [REDACTED] residence and gathered some surveillance footage of what appears to be a white Ford Taurus patrol vehicle pass in front of [REDACTED] residence (12/17/19) once at approximately 5:42 PM. What is believed to be the same vehicle can be seen sitting at the stop sign in front of the victim's residence again at 5:44 PM.

On 7/9/2020, I confirmed (via official Computer Aided Dispatch logs) that on 12/17/2019, Dedorius Varnes logged on as unit 311 at approximately 5:48 AM, and then logged off as unit 311 at approximately 6:02 PM.

On 7/9/2020, I reviewed the GPS results from Dedorius Varnes GPS, which is mounted on or about his agency laptop. I reviewed the date of 12/17/2019 12:00 PM until 6:00 PM, in particular.

I identified that at approximately 5:35 PM (12/17/19), the vehicle avatar associated with Dedorius Varnes on that date (311) is observed passing [redacted] residence at approximately 5:42 PM, then continuing north. The vehicle avatar then appears to turn around, and come to a stop or near complete stop in the vicinity of [redacted] residence again at approximately 5:47 PM. The vehicle avatar then travels west until it finally arrives at Dedorius Varnes residence at approximately 5:56 PM. The avatar for unit 311 appears to go offline at approximately 6:02 PM.

On 7/9/2020, I verified via Computer Aided Dispatch (CAD) records, that Dedorius Varnes' did not have any calls for service, and no legitimate law enforcement purpose for travelling on the street that [redacted] and C.P. reside at on 12/17/2019. I also verified that the path travelled by Dedorius Varnes on 12/17/2020 between approximately 5:40 PM and 5:48 PM, are completely out of the way for him, as he was travelling to his residence.

On 7/10/2020, I requested audio confirmation that on 12/17/2019, patrol unit 311 was in fact Dedorius Varnes. I was provided with an audio recording of a unit believed to be Dedorius Varnes on the radio, identifying as unit 311 on the date in question.

On 7/10/2020, I verified that Dedorius Varnes timecard showed he was working on 12/17/2019. The timecard was signed by his supervisor, Corporal Robert Myers.

On or about 7/13/2020, I verified that two of the numbers that (386) 463-3857 was in communication with are/have previously been associated with Dedorius Varnes. I requested that the Flagler County Sheriff's Office Real Time Crime Center provide me with the full names and most current addresses associated with the two numbers. I was provided that information on or about 7/13/2020.

On 7/13/2020, Detective Rodriguez and I responded to Palatka, Florida, where we made contact with an individual (C.T.) who was at several points (between approximately 2013 and early 2020) engaged in an "on/off" relationship with Dedorius Varnes. Detective Rodriguez and I gathered a sworn statement from C.T.. During the statement C.T. was shown text messages between her cellular phone number, and (386) 463-3857. C.T. indicated that she had the conversation in question with Dedorius Varnes. C.T. stated that Dedorius was being "real sneaky" and not using his "main number" when she was communicating with him in late 2019.

On 7/13/2020, Detective Rodriguez and I responded to St. Augustine, Florida, where we made contact with an individual (J.V.) who was at several points (between approximately 2008 and early 2020) engaged in an "on/off" relationship with Dedorius Varnes. Detective Rodriguez and I gathered a sworn statement from J.V.. During the statement J.V. was shown text messages between her cellular phone number and (386) 463-3857. J.V. indicated that she had the conversation in question with Dedorius Varnes. J.V. indicated that she believed the phone number she was communicating with Dedorius Varnes on was a secretive "Text Free" type number in late 2019. **\*\*\*NOTE: At approximately the same time (between approximately 9:54 AM and 11:13 AM on 12/16/2019) J.V. recalls communicating with Dedorius Varnes on his "Text Free" number, the (386) 463-3857 number was engaged in threatening text messages with the victim.\*\*\***

On 7/14/2020 at approximately 1:48 PM, I met with Deputy Christopher Crego of the Flagler County Sheriff's Office. Deputy Crego provided me with a sworn/audio recorded statement. Christopher Crego has been Dedorius Varnes' "zone partner" for approximately two (2) years. According to Christopher Crego, Dedorius Varnes had expressed to him that he was "talking to" J.V. and that his "wife" had discovered this. Christopher Crego indicated that he assumed Dedorius was engaged in a secretive, intimate relationship with J.V. based on the way the relationship was portrayed to him by Dedorius Varnes.

On 7/17/2020, I made contact with Detective Fuentes, who advised that during his sworn interview with Dedorius Varnes, Varnes confirmed the existence of a secondary phone. According to Varnes, he got rid of the phone in question in approximately January of 2020. Varnes advised Detective Fuentes that he used the phone in order to communicate with his "ex" believed to be J.V..

On 7/17/2020, I reviewed an audio recording of Dedorius Varnes statement with Detective Fuentes. During the interview, Dedorius advised Detective Fuentes that he had an affair with his "ex-wife" (J.V.) when he should not have been. Dedorius implies that he was "caught" with "the other phone" by his current fiancé. Dedorius estimated that this was "months" ago. Dedorius Varnes states that he was "caught" cheating in January (2020).

On 7/17/2020 at approximately 1:54 PM, Detective Rodriguez and I responded to the residence of Dedorius Varnes. I knocked on the door and asked if Dedorius would come out and speak with us, and he did. At this

time, we had a non-custodial interview with Dedorius. I explained to Dedorius that I had received other complaints about him, and I wanted to see if he wanted to talk to us. Dedorius remained outdoor and agreed to speak with us. During the interview, Dedorius was allowed to go into his residence, close the door, and come back out again. I explained to Dedorius that J.V. had told us that she was communicating with Dedorius on a "secondary phone".

Dedorius confirmed that he was speaking to J.V. and C.T. on the same phone.

Dedorius Varnes Dedorius indicated that "sometimes" when he would fall asleep at work, people might take his phone or drive his patrol vehicle around.

As of 7/17/2020, I have not located any records, statements, or evidence of any kind to suggest that Dedorius Varnes and or C.P. have ever communicated or had any type of relationship or altercation prior to 11/27/2019.

As of 7/17/2020, I have not located any records, statements, or evidence of any kind to suggest that Dedorius Varnes and or C.P. ever communicated or had any type of relationship or altercation after 12/18/2019.

All of the evidence gathered during this investigation indicates that the only motive Dedorius Varnes had, to text was retaliation for the complaint filed by with the Flagler County Sheriff's Office on 11/28/2019.

### CONCLUSION


Based on the above investigation and supporting documentation I, Corporal Hristakopoulos, believe there is probable cause that Dodorius Varnes violated the following statutes:
