ED recalls waking up to the male licking his anus without his consent. Furthermore, a sexual assault exam was completed. The victim does not have clear memory of anal penetration but has anal bleeding and significant pain on the exterior and interior of his anus. All of these sexual incidents occurred without the consent of the juvenile victim and furthermore the victim is not of age to consent to a person 42 years of age due to only being 16 years of age.								
During a controlled telephone call between Victor Williams and Nicole Hartline, Victor Williams admits to sexual anal intercourse with victim, ED. Victor also admits to providing the juvenile with alcoholic beverages and having to care for him because he was so intoxicated while they were together.
