1) HOW VIOLATION OCCURRED:

Violation of Condition (9) of the Order of Drug Offender Probation, by failing to comply with all lawful instructions given to her by the probation officer, and as grounds for belief that the offender violated her probation, Officer Daniel Ford states that on 11/16/2022, the offender was instructed to remain in the probation office lobby until she could provide a valid urinalysis and the offender did fail to carry out this instruction by leaving the probation office

Violation of Condition (15C) of the Order of Drug Offender Probation, by refusing to submit to a random urinalysis, breathalyzer, or blood test at any time requested by the officer to determine possible use of alcohol, drugs, or controlled substances, and as grounds for belief that the offender violated her probation, Officer Daniel Ford states that the offender refused to submit to a urinalysis test on 11/16/2022, as evidenced by leaving the probation office against the instructions of the probation officer.

Circumstances: On 11/16/2022, the offender reported for her scheduled office visit. Officer Glodava witnessed her urinalysis and determined that it was an invalid sample. This officer instructed the offender to remain in the probation office until she could produce a valid sample. The offender left the office and never returned.

The offender stated that her ride would not wait for her.

**4) RECOMMENDATION:**

This officer is requesting a warrant for the arrest of this offender and a revocation of her drug offender probation. This offender has a history of non-compliance, and this latest violation follows a familiar pattern. This offender does not make a good candidate for further supervision.
