The Probationer has failed to complete a recommended Psychosexual Treatment.


The Probationer has failed to complete all conditions of probation in a timely manner.



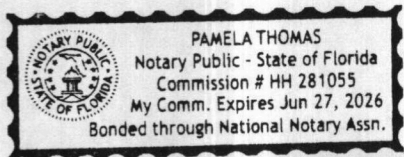
