about money. [REDACTED] advised during the argument she felt uncomfortable and ran out of the house through the backyard. [REDACTED] stated living in this house is terrible and it's the worst place she's ever lived. [REDACTED] ran through a hole in the fence towards a swale and the back street (Oak Trails Blvd). [REDACTED] stated she tripped over a pallet in the back swale and fell to the ground. Walsh chased [REDACTED] out of the house following her to where she fell. [REDACTED] advised he lent a hand to help pick her back up. Per [REDACTED] she was telling Walsh not to touch her during this. [REDACTED] denied Walsh hitting or threatening her. [REDACTED] advised she is bi-polar and has a past history of abuse from men. [REDACTED] used this to explain her behavior. During later questioning, [REDACTED] told Deputies she grabbed her phone to call law enforcement prior to running outside. [REDACTED] advised after she grabbed her phone Walsh snatched it back out of her hands. [REDACTED] advised she does not wish to pursue charges and denied medical assistance. [REDACTED] completed and signed a FCSO written statement and confidentiality form.

Deputies then made contact with Donna Carvalho who was an uninvolved and independent witness. Carvalho advised she was driving eastbound along Oak Trails Blvd when she observed a man on top of a woman in the road. The male was later identified and Walsh and the Woman was [REDACTED]. Carvalho advised [REDACTED] was laying on her back with Walsh on top of her. [REDACTED] was striking [REDACTED] with both his closed fists into her torso. Per Carvalho, [REDACTED] struck her multiple times. Carvalho advised [REDACTED] appeared to be in fear and they were definitely not playing around. Carvalho honked her horn, which Walsh initially ignored. Walsh then picked [REDACTED] up with his arms around her waist and "dragged" her back into the woods behinds the fence. Carvalho completed and signed a FCSO written statement.

Deputies then made contact with Maryanne Tompkins who is another uninvolved and independent witness. Tompkins advised she heard a female screaming "help me, help me" while she was at her residence on Blaine Dr across from Oak Trails Blvd, Palm Coast. Tompkins heard a male talking to the screaming female and observed vehicles slowing down but not stopping. Tompkins could not see details of the disturbance due to her backyard fence. Tompkins drove around to check on the incident but arrived after law enforcement. Tompkins completed and signed a FCSO written statement.

Deputies made contact with Angelo Walsh at 17 Blasdell Ct, Palm Coast. Walsh advised the following post Miranda: They were talking about furniture and her cellphone inside the residence. Walsh denied

them fighting. Walsh stated she ran out of the house into the backyard but could not advise what caused her to do this. Walsh advised he ran after her having fun and being playful. Walsh stated [REDACTED] ran through the hole in the fence. Walsh followed her and struck the top of his head on a crossbeam in the hole of the fence. In response to being asked to elaborate, Walsh advised he ran over, grabbed [REDACTED] and picked her up. Walsh further stated [REDACTED] was "not screaming for help or anything like that, we were playing". Walsh declined medical assistance. Walsh provided a verbal statement.

Deputies provided [REDACTED] with a FCSO case number and informed her to contact the Flagler County Sheriff's Office with any further information or questions. [REDACTED] received a FCSO Domestic Violence Victims Rights pamphlet. A victim's notification card was completed and later provided to the inmate facility. I observed a fresh scratch to [REDACTED] ankle. She had dirt and a small amount of blood smeared on her hands. [REDACTED] was covered in dirt and older injuries which have scabbed over. Photographs were taken then uploaded to digital crime scene.

I requested a criminal history check for Walsh via FCSO TTY. The criminal history check revealed two prior battery charges with one prior battery conviction.

Deputies conducted a search incident to arrest. The search revealed a small baggy of blue pills in Walsh's left pocket. There were 19 pills and the cotton head of a Q-tip inside the baggy. The pills were blue in color and marked with LL on one side and the other side displayed C/42. The pills were identified as Clonidine Hydrochloride 0.1 mg utilizing "Drugs.com", which also stated the medication is available by prescription only.

Walsh advised the pills are for his ADD. He stated he did not have a prescription for them because they are non-narcotic.

Angelo Walsh was arrested for battery (domestic violence) with a felony upcharge due to his prior battery conviction and unlawful possession of new drugs or legend drugs without prescription. Walsh was transported to FCIF for processing.
