

she was woken up to hearing Michael Brougher's voice yelling to get Mr. Walsh off of her. [redacted] advised when she awoke, she felt and saw Mr. Walsh's hand inside of her bra touching her breast. [redacted] completed a sworn written statement.

I then spoke with Michael Brougher, who advised at approximately 1530 hours, he saw Mr. Walsh laying next to [redacted] with one hand under her shirt and one inside her shorts. Mr. Brougher stated he yelled which had Mr. Walsh run off. Mr. Brougher completed a sworn written statement.

At 1958 hours, Mr. Walsh was located at 105 E. Lambert St. Officer Bagwell provided a show-up with [redacted] to identify Mr. Walsh as the male who touched her. [redacted] confirmed Mr. Walsh to be the male who was touching her when she awoke.

Mr. Walsh was read his Miranda Rights from my department issued Miranda Card and advised he still wished to speak with me. Mr. Walsh would not confirm or deny touching [redacted]. However, Mr. Walsh stated he might have been trying to "get with" her. When asked Mr. Walsh if he touched [redacted] he stated "whatever happened, happened" and advised he no longer wished to speak with law enforcement.

Mr. Walsh was transported to Flagler County Inmate Facility without incident. BWC Recording.
