ORDER GRANTING MOTION TO CORRECT SENTENCING ERROR/
ADDITIONAL COUNTY JAIL CREDIT

This matter is before the Court on the Defendant's Motion to Correct Sentencing Error alleging Defendant Copeland is entitled to additional County Jail Time. Having reviewed the record and being otherwise fully advised in the premises, this Court finds as follows:

The Defendant alleges he was arrested on the warrant in this case on May 21, 2011 in Volusia County. The time served credit awarded to him *sub judice* began on May 23, 2011, when he was transferred to the Flagler County Inmate Facility. A review of the record shows that Defendant Copeland was arrested May 21, 2011 in Volusia County on the Flagler County warrant signed by the Honorable Raul Zambrano on May 19, 2011, and entered by the Flagler County Sheriff's Office on May 20, 2011. See attached Volusia County Charging Affidavit.

Therefore, it is

ORDERED and ADJUDGED the Defendant's Motion is Granted; the Defendant, William Copeland shall be credited an additional 2 days, for a total of 574 days in the above styled case.
