NARRATIVE The undersigned certifies and swears that there is probable cause to believe that the named defendant, on the <u>27th</u> day of <u>June</u> , <u>2013</u> , at approximately <u>10:50</u> <input type="checkbox"/> a.m. <input checked="" type="checkbox"/> p.m. at <u>164 Espanola Rd. Bunnell</u> within <u>Flagler</u> County, violated the law and did then and there:				
<p>On June 27th, 2013 at approximately 10:50 pm four black males unlawfully entered the victim's residence located at 164 Espanola Rd. Bunnell. The males had their faces covered and the first male to enter carried a baseball bat. The first male with the baseball bat pushed the victim out of his wheelchair to the floor. The male then held the victim to the floor by placing his foot on the victim and striking him with the aluminum baseball bat. The additional black males entered the residence and went directly into a room where several firearms were stolen. The male with the baseball bat also repeated, "Where's the shit". The victim wasn't sure what the males wanted. The males also took the victim's wallet which contained his driver's license, debit cards, and approximately \$60 cash.</p> <p>On July 1, 2013, two stolen firearms were recovered in Espanola with the assistance of six residents/witnesses. Information obtained from anonymous tipsters and an alleged eye witness within Espanola identified the suspects as Juvenile Justin Mickens, Juvenile Earnest Watson aka "Pernie", Juvenile [redacted] and [redacted].</p>

On July 2, 2013 consensual contact was made with the following individuals by Detective Conrad on Knox Jones Ave. Bunnell.

These individuals were believed to have knowledge of the Home Invasion. The conversations were recorded and summarized as follows;

- Justin C. Mickens: While speaking with Justin I presented him with a list of names that I received identifying the suspects of the home invasion which included his name. Justin Mickens (who turned 18 years old on June 29, 2013) admitted to being involved in the home invasion. I asked Justin who had the baseball bat; Justin stated he didn't know who had the baseball bat "It was like a fast motion". He further stated "I was already in the room", referring to the room to the right where the guns were stolen from. I asked Justin if he knew where he was going or if he had ever been in the house before. Justin stated "I've never been in the house before". Justin also agreed to apologize to the victim.
- [REDACTED] While speaking with [REDACTED] I presented him a list of names that I received identifying the suspects, which included his name. [REDACTED] initially denied having anything to do with it, however later stated "the reason we did it is because little Sean ****inaudible*** and we just wanted to be followers". [REDACTED] also agreed to apologize to the victim.

On July 5, 2013 several individuals voluntarily responded to the Flagler County Sheriff's Office Investigations Division to provide voluntary sworn statements. Justin Mickens and Juvenile [REDACTED] were two of the individuals that responded who I previously spoke with. During the statements two individuals, identified as Justin Mickens and Ernest Watson aka Pernie confessed to the home invasion and provided sworn statements revealing their involvement in the home invasion and gun thefts. The video statements will be placed into Flagler County Sheriff's Office evidence.

The above defendant, Eugene Watson, provided a voluntary sworn statement which is summarized as follows; E. Watson stated he knows he's gonna go down for it either way so he would tell this detective what happened. E. Watson stated it was a spur of the moment thing and, "I didn't hit that man and I didn't do nothing". E. Watson stated he only went in and took the guns and he didn't take anything else. He stated there were only three guns. E. Watson stated they said he told them to let the man get up, until the man started to reach for something, "then he was like no". He stated the man was never "hit" with the baseball bat, he was just tapped with the bat. E. Watson stated, "I know I messed up and I know I did it" and stated he has been praying. I asked E. Watson who had the baseball bat and he stated Lil Sean had the bat during the home invasion. E. Watson stated he tries to stay out of trouble although there's nothing to do in Espanola. He stated he was supposed to start a job Monday. E. Watson stated they were told by a male identified as Norman Irving that there were guns in the victim's house. He also stated they knew there were pills in the house. E. Watson stated Sean Giddens was the male that was asking "where's the shit". E. Watson stated he didn't know where the other gun was but assured this detective it wasn't in Sean's house. E. Watson stated [REDACTED] wasn't involved in the home invasion. E. Watson stated he got two of the victim's ID/debit cards and he knew where they were. He stated he could get them and described they were in the bushes in the path by the little abandoned house off Knox Jones Rd. E. Watson later returned a Bank of America Debit card to this detective with the victim's photo on it.

E. Watson stated him and Justin Mickens are the ones that took the guns from the victims house.
 E. Watson explained they ran after the home invasion to Lil Sean's house and put all the guns inside the house and continued walking down Espanola Rd. and left. He stated they hid because he knew the police would get called.
 E. Watson stated the home invasion wasn't as bad as "what they could have did". He stated anybody else would have tried to beat him to sleep. E. Watson stated he never tried to hurt the guy. E. Watson stated Sean didn't kick the victim but just placed his foot on him to hold him down. E. Watson stated the victim said "My heart my heart, where's my medicine" and Sean said "where's it at?" E. Watson stated it wasn't as bad as it was said in the paper. E. Watson stated that initially Sean escorted the man to the ground out of his wheelchair. He stated he didn't throw him down.
 E. Watson stated if he does get charged he hopes he gets probation, because there are people that have done worse than this and got probation. I asked E. Watson what he had planned on doing with the guns and he stated they just wanted to have them for the 4th of July and then they were going to try to get rid of them by selling them. E. Watson stated the real big gun was the one he was calling his and identified it in a pic I showed him that was previously taken. E. Watson stated he has been hanging out with Sean after the home invasion but they haven't talked about it.
 E. Watson stated when they ran from the victim's house that night after the incident, he ran first, then Justin and then Sean. E. Watson stated he carried two guns and Justin carried one. He further described a gun being by the entrance of the bedroom (also described by the victim).
