towards the arresting officer. He stated "you don't wanna do this" "a whole bunch of motherfuckers hitting the floor" "don't you forget this day you pussy bitch". Multiple times he stated "aint no fun when the rabbit has a gun". This is believed to reference Weeks having a gun and being the rabbit. Weeks stated he wished there wasn't so many microphones in the car while being transported to FCIF. Once in the sally port waiting to enter the jail Weeks stated, "Weeks continued to ask about the arresting deputies family and inquiring if he had kids. Weeks repeatedly asked the arresting Deputy to fight him and sign a waiver. He stated he would break all the bones below the arresting Deputy's nose. Weeks stated "I will tear your god damn ass up" "I'm gunna fuck you up when I get out you pussy bitch." Prior to arrest, Deputy Boyd was standing with Weeks near the driveway while I was speaking to the victim. Weeks told Deputy Boyd "im gunna whoop his ass" while talking about the arresting deputy. He also made a statement about not wanting to live and that law enforcement would have to shoot him. Weeks also stated he looked up the value of the stolen tractor online while in the back of the patrol car waiting to enter the jail. The incident and threats were captured on body worn camera and uploaded to Evidence.com.
