On January 21, 2016 the Flagler County Sheriff's Office served a search warrant at 55 Lincoln Ave. Bunnell. The warrant was issued due to the occupants of the residence possibly being in possession of stolen firearms. Upon contact with the occupants one male, identified as Joseph M. Westervelt was found in possession of a loaded revolver in his waistband. There were also nine additional rounds found in his pocket. Joseph M. Westervelt was confirmed to be a convicted Felon in the State of Florida. Upon further search of the residence three assault rifles were located in a back bedroom. Additional ammunition was also located within the residence.					
J. Westervelt was advised of his Miranda Warnings and chose to speak with detectives. J. Westervelt admitted to buying the rifles located in the back room and also buying the handgun located in his waistband. J. Westervelt also acknowledged the crime of owning such firearms while a convicted felon.					
J. Westervelt was transported to the Flagler County Inmate Facility without incident.
