Dear Ms. Fuller

As I read the position description, I became excited by the opportunity to return to my roots in County/City management. I have specialized in strategically managing complex organizations in the public sector and delivering measurable results.

My first appointment as city manager was in Lincoln Heights, Ohio at the age of twenty-six (26). I have served as the Director of Neighborhood Economic Development for the City of Cincinnati. I then served as deputy city manager and city manager for the City of Gainesville and assistant city manager for Riviera Beach, Florida. Demonstrating my versatility, the last six years I have served as the Assistant Superintendent for Operations for the Alachua County School District (Gainesville). In that position, I have supervised Human Resources, Safety, Facilities, Food, and Nutritional Services, Transportation, and Risk Management.

I have extensive management experience on the administrative side and operating departments of the city. My resume reflects my extensive experience with turning challenges into opportunities. In Gainesville, Fla, the city commission had a vision of being the most livable city in the country. We achieved that goal when Money Magazine designated Gainesville the Most Livable City in the Country. Annexation was also key to the City Commission's vision in Gainesville, and we achieved the first voter-approved annexation in the history of the county. The city of Riviera Beach did not have a funded CIP program. Through a series of mechanisms, I created the ability to have a fully funded CIP program which led to the redevelopment of the city's park system and routine street maintenance. As assistant superintendent for operations, I identified and recommended to the superintendent a ½ sales tax initiative for a combined \$500,000,000 facilities initiative for a 12-year period which passed in 2018. This is the largest capital projects initiative the County's history. This initiative is front-loaded with a \$110,000,000 bond. Funding became available in 2019. To date, two transition schools have been completed with four schools scheduled to open in 2021. The district is ahead of the 3-year bond requirement scheduled to have all funds obligated. I have led visioning processes to achieve consensus on issues involving growth management and redevelopment in a manner similar to what the City of Palm Coast engages, by reviewing the strategic plan and the comprehensive plan annually. The next step is to have all departments focused on achieving the policy directives of the policymakers. The Facilities and Maintenance department maintains 5,000,000 sq. ft. of facilities. We developed the COVID-19 protocols for the 41 schools. I have directed fleet management programs including public transit. The fleet replacement program I instituted with the school district to date has resulted in \$720,000 plus annual savings in fuel and maintenance costs for the yellow bus fleet. This includes a \$.81 reduction in operating cost per mile. I have extensive experience in economic development on a national basis. I understand how to communicate with the business and finance communities.

My extensive experience in a coastal community with a barrier island translates to an understanding of the required balance between growth and the environmental and regulatory issues involved with development.
