On October 16, 2023, I detective Broomfield, was assigned this case for further investigation. I who confirmed the above sequence of events. stated Samantha has become upset due to him having a new girlfriend and that she has been trying to get him in trouble with the courts over things he is doing that she does not approve of. confirmed he knew Samantha had hired a private investigator and on a couple of occasions because he has had interactions with the P.I. in front of his residence. stated he knows it is legal to hire a private investigator; however, since finding the Tile device he knows Samantha has been tracking him utilizing that which he is not ok with. On October 16, 2023, Samantha reached out to a member of the Flagler County Sheriff's Office asking why her ex-husband's vehicle has been parked at the Sheriff's Office Operations Center for the past 2.5 hours. It was relayed to Samantha that no one was aware of any reason why he would be there. It was not relayed to was at the Sheriff's Office or not. After receiving this information, I contacted to inquire about his whereabouts for the day. advised he works in Holly Hill and clocked in for work at 8:37am and had been there ever since. I spoke with the Evidence Technician in reference to the location of the Tile tracker. Evidence Technician Hazel Faircloth advised she picked up the Tile tracker from the Palm Harbor substation evidence locker that morning and drove it straight to the Sheriff's Office Operations Center. After obtaining whereabouts as well as the information from the Evidence Technician, it was identified that Samantha had been tracking location utilizing the Tile Tracking device. On October 24, 2023, Sergeant Hristakopoulos and I met with Samantha at her place of employment. It was relayed to Samantha that we received a report from her ex-husband that she had been following him. Samantha began by admitting to hiring a private investigator due to not following the court ordered
