On 3/24/2011 at 15:15pm I responded to Indian Trails Middle School in reference to a weapons complaint. Upon arrival I was

met by the Principal (Vernon Orndorff) who advised me that he had a parent call in from the Indian Trails Sports Complex stating that she observed a black male (Travis Williams) pull out a handgun from his backpack and showed it to several other students at the park. She further stated that the juveniles walked back to the school and are now at the gymnasium. Myself and the principal made contact with Travis and he denied having a weapon and we asked him where his book bag was and he told us that another student by the name of [REDACTED] had his book bag. I was able to make contact with [REDACTED]'s mother ([REDACTED]) advising her what was told to me about the book bag. [REDACTED] told me that [REDACTED] was signed out early and had been with her ever since and was not at the school. After speaking with [REDACTED], an anonymous student alerted us that his book bag was in the wood line in the back of the school. [REDACTED] I was unable to locate the gun in the book bag so Travis walked us back to the wooded area where he threw his book bag and at that time we located the weapon.

At that time I placed Travis under arrest for possession of a concealed weapon and possession of a concealed weapon on school campus. Travis was transported to Flagler County Inmate Facility for booking. The handgun was placed into evidence for court.

I also made contact with Mrs. Williams and made her aware of what was going on and that I will be making contact with her to let her know if her son will be released to her or will be transported DYS. Nothing further at this time.

Travis was trespassing that afternoon on school campus, but was not charged with this crime, since he did not have permission from the principal to be there.
